## RESOLUTION No. 23-123

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING MODIFICATIONS TO THE GOOD LIBATIONS SPECIAL EVENT PERMIT ISSUED PURSUANT TO RESOLUTION No. 23-45, TO LIBERATION EVENT MANAGEMENT, LLC; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on April 12, 2023, pursuant to Resolution No. 23-45, the City of Doral ("City") approved a special event permit for Liberation Event Management, LLC (the "Applicant") to host the "Good Libations Festival" at the Downtown Doral Park on November 11<sup>th</sup> and November 12<sup>th</sup>, 2023; and

WHEREAS, on June 26, 2023, the Applicant contacted the City's Planning and Zoning Department requesting a series of modifications to the approved special event permit, including to change the event name to "Festival of Flavors" and to reduce the event to a single day; and

WHEREAS, the Applicant is also requesting the use of the City logo to market the event under the new name "Festival of Flavors"; and

**WHEREAS**, staff has reviewed the proposed modifications and recommends that the Mayor & City Council approve the request to modify the approved special event permit.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

**Section 1. Recitals.** The above recitals are true and correct and incorporated herein.

**Section 2**. **Approval.** The Applicant's request to modify the special event permit approval as follows is approved:

- 1. Change the event name from "Good Libations Festival" to "Festival of Flavors."
- 2. Reduce the event to one day, so that it takes place only on November 12, 2023, from 12:00 pm to 6:00 pm.
- 3. Retain the use of the City logo under the event's new name "Festival of Flavors."

Except as specifically modified herein, all other conditions of Resolution No. 23-45 shall

remain in full force and effect.

Section 3. Effective Date. This Resolution shall take effect immediately upon

adoption.
