#### **RESOLUTION No. 19-208**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY'S CODE OF ORDINANCES, APPROVING THE PURCHASE OF THREE HUNDRED (300) DIGITAL PERSONA ENTERPRISE SERVER LICENSES FOR DUAL **FACTOR** AUTHENTICATION WITH ONE (1) YEAR SUPPORT AND TRAINING, AND THREE HUNDRED (300) DIGITAL PERSONAL 4500 FINGERPRINT READERS FROM CDWG LLC VIA FLORIDA NVP SOFTWARE 43230000-NASPO-16-ACS-SVAR (ADSPO16-130652) IN AN AMOUNT NOT TO EXCEED \$65,847.00; AUTHORIZING THE CITY MANAGER **EXECUTE** TO CONTRACTUAL DOCUMENTS AND EXPEND BUDGETED FUNDS **FURTHERANCE** HEREOF: **PROVIDING** IN FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the IT Department continues to conduct due diligence to protect the City's computing environment to mitigate cyber attackers gaining access to employee devices or servers; and

WHEREAS, Currently, the City relies on single-factor authentication (SFA), in which the user provides only one factor which is a password that can be compromised by brute force or social engineering. Two-factor authentication adds an additional layer of security to the authentication process by making it harder for attackers to gain access to a person's devices because knowing the victim's password alone is not enough to pass the authentication check; and

**WHEREAS**, section 2-322 of the City Code of Ordinances provides that the City may enter into contracts competitively entered into by other governmental entities; and

WHEREAS, CDWG LLC is a vendor participating in State of Florida Contract NVP Software 43230000-NASPO-16-ACS-SVAR (ADSPO16-130652 as specified in the

quotes attached hereto as Exhibit "A" (the "Quotes"), which are incorporated herein and made a part hereof by this reference; and

WHEREAS, staff has recommended the Mayor and City Council Members the purchase of three hundred (300) Digital Persona Enterprise Server Licenses for Dual Factor Authentication with one (1) year support and training and three hundred (300) Digital Personal 4500 Fingerprint Readers in an amount not to exceed \$65,847.00. Funds have been allocated in the FY1819 "Repair and Maintenance" Account #: 001.22005.500460

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. Pursuant to section 2-322 of the City Code of Ordinances, the procurement of the three hundred (300) Digital Persona Enterprise Sever Licenses for Dual Factor Authentication with one (1) year support and training and three hundred (300) Digital Personal 4500 Fingerprint Readers in an amount not to exceed \$65,847.00, via State of Florida Contract NVP Software 43230000-NASPO-16-ACS-SVAR (ADSPO16-130652 from CDWG LLC, in accordance with its quotes in Exhibit "A", is hereby approved.

Section 3. Authorization. The City Manager is hereby authorized to enter into an agreement and other contractual documents, subject to approval as to form and legal sufficiency by the City Attorney, as may be necessary to procure the three hundred (300) Digital Persona Enterprise Sever Licenses for Dual Factor Authentication with one

(1) year support and training and three hundred (300) Digital Personal 4500 Fingerprint Readers, and to expend funds in furtherance hereof.

**Section 4. Implementation.** The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.
