MOST RESPONSIVE AND RESPONSIBLE BIDDER: APPROVING AN AGREEMENT BETWEEN THE CITY AND KVC CONSTRUCTORS. INC IN AN AMOUNT NOT TO EXCEED FUNDING ALLOCATED WITHIN THE GENERAL OBLIGATION PARKS BOND ESTIMATED AT \$8,500,000.00 FOR THE CONSTRUCTION OF THE DORAL CULTURAL ARTS CENTER; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH THE NEXT QUALIFIED FIRM SUCCESSIVELY IF AN AGREEMENT CAN NOT BE NEGOTIATED WITH THE TOP RANKED FIRM; AUTHORIZING THE CITY MANAGER TO EXECUTE THE AGREEMENT AND EXPEND ALLOCATED FUNDING FROM WITHIN THE GENERAL OBLIGATION PARKS BOND ON BEHALF OF THE CITY IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION: AND PROVIDING FOR AN **EFFECTIVE DATE**

WHEREAS, the proposed Downtown Doral Cultural Center is conceived as a place in which the community can gather to enjoy art, cultural activities and events that is representative of the beautiful City of Doral; and

WHEREAS, During the October 10, 2018 council meeting, the city council approved Resolution No. 18-179 which approved the conceptual design of the Downtown Doral Cultural Center; and

WHEREAS, On November 6, 2018, City of Doral voters approved the Parks Bond Referendum providing the City with the funding mechanism needed to proceed with the design, permitting, and construction of the projects outlined in the bond. The Downtown Doral Cultural Center is one of the projects as part of the Bond Referendum; and

WHEREAS, Request for Qualifications No. 2019-01 was issued on January 4, 2019 and the top three ranked firms were shortlisted to participate in the future

competitive proposal phase of this solicitation (Invitation to Bid – ITB); and

WHEREAS, in response to Invitation to Bid #2020-21 for "Doral Cultural Arts Center" (the "Project"), the City received three (3) bids from the shortlisted-firms by the August 21st, 2020 deadline with all teams meeting the required criteria; and

WHEREAS, upon review of bids received, and after conducting descoping meetings with all three firms, staff determined that KVC Constructors, Inc was the lowest most responsive and responsible bidder (the "Contractor"); and

WHEREAS, a copy of Contractor's Bid Submittal which includes the Construction Contract, ITB #2020-21 Inventory, and Bid Tabulation are all attached as Exhibit A; and

WHEREAS, the City Council finds that accepting the bid and entering into a contract for the Project with the Contractor in a not to exceed amount of \$8,500,000.00, which includes an approximate 10% contingency for any unforeseen conditions, is in the best interest of the City; and

WHEREAS, funds for these services will be allocated from the Park Bond Fund estimated at \$8,500,000.00 in Fiscal Year 2019-20 in account number 303.9000572.500650; and

WHEREAS, funding for future change orders may be allocated from the Parks and Recreation Department Funds.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The contract between the City and KVC Constructors, Inc for the Project in an amount not to exceed funding allocated within the General Obligation Parks Bond, together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney, is hereby approved.

Section 3. Authorization. The City Manager is authorized to execute the construction contract and expend budgeted funds on behalf of the City.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date</u>. This Resolution shall take effect immediately upon adoption.
