# ANIMAL POPULATION STEERING COMMITTEE 2013-2014 ANNUAL REPORT

The purpose of the committee is to review existing and new programs aimed at the control of the stray animal population in the City. Additionally, the committee is working for the potential implementation of a City wide program aimed to do the same. Items and processes currently reviewed include:

- Trap Neuter and Release (TNR) programs in place at local communities;
- Impacts of unfettered increase in animal population;
- Education of pet owners as to the benefits of animal control.

### STRAYS TRAPPED AND RESCUED AND VARIOUS OUTCOMES:

Approximately 130 Trapped and Rescued (includes Injured and Kittens) Stray Cats.

#### **Overall TNR Report:**

- Returned: 85 (approximately)
- Adult Cats Adopted: 4 (very few people are remarkable enough to adopt an adult cat)
- Adult Cats Fostered: 9 (some returned, some adopted)
- Kittens Adopted: 15 (includes Locally, Statewide and Out of State Maryland)
- Kittens Fostered: 18 (some still Waiting For Their Forever Home)
- Cats Spayed/Neutered and Vaccinated: ALL of them (except the ones that were too ill for surgery)
- Injured Adult Cats and Kittens Cared for: 15 (all fostered, some adopted, some returned)
- Cats Euthanized: 8 (we tried to save each one of them by all means possible) \*Committee member Leonor Rodriguez wishes to note that she doesn't believe in euthanasia

## One of the committee's next initiatives is to contact local veterinary clinics and local veterinary Doctors and ask them to consider helping us with low cost services when we find injured animals

#### **Budget Allowance:**

We were able to buy minimum baseline equipment with the \$1,500 that Council approved in 2013. We respectfully ask again for funds to buy much needed equipment and supplies. Mr. Adam Temple, our committee's liaison, was in charge of the purchase. He can report to Council anytime.

We ask Council to consider \$2,500 for additional equipment and supplies.
