A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN AMENDMENT TO THE EXECUTED PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF DORAL AND WOLFBERG, ALVAREZ & PARTNERS, INC. TO PROVIDE ADDITIONAL DESIGN SERVICES FOR THE POLICE EXPANSION PROJECT IN AN AMOUNT OF \$14,990.00; APPROVING AN INCREASE TO THE TOTAL NOT-TO-EXCEED CONTRACT AMOUNT TO \$377,885.00; AUTHORIZING THE CITY MANAGER TO EXECUTE THE PROFESSIONAL SERVICES AGREEMENT AMENDMENT AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on January 15, 2014, the City Council for the City of Doral (the "City") adopted Resolution No. 14-15 authorizing the City Manager to negotiate a Professional Services Agreement ("Agreement") with the Firm Wolfberg, Alvarez and Partners ("Consultant") for architectural and engineering services for the Police Facility Expansion Project ("Project") in a not to exceed amount of \$310,460; and

WHEREAS, on February 19, 2014, Council adopted Resolution No. 14-33, authorizing the City Manager to include LEED/Sustainability Consulting Services in the Agreement, and increase the Contract Amount to a not to exceed amount of \$362,895; and

WHEREAS, the City of Doral Police Department requested certain additions and modifications to the Project in order to enhance organizational tasks and security (see correspondence provided in Exhibit "A") (the "Additional Services"); and

WHEREAS, in response to the City request, the Consultant provided a proposal for the Additional Services, attached hereto as Exhibit "B" (the "Proposal"), which is incorporated herein and made a part hereof by this reference, for a total not to exceed amount of \$14,990.00; and WHEREAS, in order to take advantage of the ongoing construction, save time, and funding on these potential future requests, staff has recommended the City Council approve the Proposal; and

WHEREAS, City staff has further requested that the City Council authorize the City Manager to execute Amendment No. 2 for the Professional Services Agreement between the City of Doral and Wolfberg, Alvarez & Partners, Inc. in order to include the Additional Design Services with the terms, conditions, and pricing stipulated in the Proposal, and amend the contract agreement to a not to exceed amount of \$377,885; and

WHEREAS, funding for this agreement is available in the Public Works Fund, Account No. 001.80005.500310.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

<u>Section 2.</u> <u>Approval.</u> Amendment No. 2 to the Professional Services Agreement for the provision of Additional Design Services as provided in the Proposal, and the increase in contract amount to a not to exceed amount of \$377,885, together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney, is hereby approved.

Section 3. <u>Authorization.</u> The City Manager is authorized to execute Amendment No. 2 and expend budgeted funds on behalf of the City in furtherance hereof.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose of the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Rodriguez who moved its adoption. The motion was seconded by Vice Mayor Cabrera and upon being put to a vote, the vote was as follows:


