

**RESOLUTION No. 14 – 176**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE APPROVAL OF THE DONATION OF ALFRED AND DORIS KASKEL'S BUSTS TO BE DISPLAYED IN A PROPER TEMPORARY LOCATION IN THE LOBBY OF THE CITY OF DORAL GOVERNMENT CENTER, AND BE RELOCATED ONCE THE CITY PURCHASES AND DEVELOPS THE TRIANGLE PARCEL, WITH THE UNVEILING CEREMONY FOR CITY COUNCIL, STAFF, AND GENERAL PUBLIC; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City Council wishes to honor the memory of Alfred and Doris Kaskel for their contributions to the growth and development of the community; and

**WHEREAS**, on the November 13, 2013 the City Council accepted a donation from the Kaskel family of a bust of Alfred Kaskel which was approved and passed by consensus; and

**WHEREAS**, after meeting with Staff, the Kaskel family commissioned a bust of Doris Kaskel with the dimensions to be approximately 1', 5" H x 1' W, with the pedestal measuring 28" H x 45" W x 16" D; and

**WHEREAS**, on May 22, 2014, Staff confirmed a location with the Kaskel family, along with the timeline for the project; and

**WHEREAS**, Proper installation and costs associated with construction will be covered by Doral Properties; and

**WHEREAS**, Staff has recommended authorization to accept the donation of the two (2) busts of Alfred and Doris Kaskel (the "Busts") and to display them in a proper temporary location in the lobby of the City of Doral Government Center, and be relocated once the City purchases and develops the triangle parcel, with the unveiling ceremony for City Council, staff, and general public.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL  
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval of Donation, Temporary Display Location & Relocation.** The donation of the Busts is hereby approved. The temporary display location of the Busts in the lobby of the City Government Center and the eventual relocation of the Busts upon the City's acquisition of the triangle parcel in Downtown Doral Park is hereby approved.

**Section 3. Authorization to Accept Donation & Display.** The City Manager is hereby authorized to accept the donation of the Busts on such terms and conditions as may be appropriate to protect and further the interests of the City for this matter. This Authorization does not create or confer any rights to Doral Properties. The City Manager is authorized to take such action as may be necessary to display the Busts in the temporary location in the lobby of the City Government Center and to relocate same upon the City's acquisition of the triangle parcel in Downtown Doral Park, provided that expenditures related with each display effort does not exceed the Manager's allowable procurement threshold of \$15,000.00.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

**Section 5. Effective Date.** This resolution shall take effect immediately upon adoption.

The foregoing resolution was offered by Vice Mayor Ruiz who moved its adoption. The motion was seconded by Councilmember Cabrera and upon being put to a vote, the vote was as follows:
