

RESOLUTION No. 11 – 08

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH FRANKLIN COMMUNICATIONS, LLC AND LOGISTICAL OUTSOURCING, INC. RESPECTIVELY FOR THE PROVISION OF NEWSLETTER PRINTING AND MAILING SERVICES IN AN AMOUNT NOT TO EXCEED \$56,000.00; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in response to RFP #2010-36 titled "Newsletter Printing and Mailing," the City of Doral received three (3) proposals by the October 6, 2010, 3:00 p.m. deadline; and

WHEREAS, upon review by Staff, it was determined one proposal submitted a lower production price for a 16-page newsletter and another proposal submitted a lower production price for a 20-page newsletter; and

WHEREAS, Staff respectfully requests that the City Council authorize the City Manager to negotiate and enter into an agreement with Franklin Communications, LLC (Franklin) and Logistical Outsourcing, Inc. (Logistical) respectively for the provision of newsletter printing and mailing services in an amount not to exceed \$56,000.00 to allow for pricing and back-up options in case of scheduling conflicts with the printing company.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AS FOLLOWS:

Section 1. The City Council hereby authorizes the City Manager to negotiate and enter into an agreement with Franklin and Logistical respectively for the provision of newsletter printing and mailing services in an amount not to exceed \$56,000.00.

Section 2. This Resolution shall take effect immediately upon adoption.
