## **RESOLUTION No. 12-93**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, ESTABLISHING A PROPOSED MILLAGE RATE OF 2.4376 TO BALANCE THE GENERAL FUND FOR FISCAL YEAR 2012-2013; ESTABLISHING THE CURRENT YEAR ROLLED-BACK RATE TO BE 2.2430 AND ESTABLISHING THE FIRST AND SECOND PUBLIC BUDGET HEARINGS AS REQUIRED BY LAW; DIRECTING THE CLERK AND MANAGER TO FILE SAID RESOLUTION WITH THE PROPERTY APPRAISER OF MIAMI-DADE COUNTY PURSUANT TO THE REQUIREMENTS OF FLORIDA STATUTES AND THE RULES AND REGULATIONS OF THE DEPARTMENT OF REVENUE AND THE STATE OF FLORIDA; ESTABLISHING THE TIME AND LOCATION OF THE FIRST AND SECOND PUBLIC HEARINGS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on July 1, 2012, the Honorable Pedro J. Garcia, Jr., Miami-Dade County Property Appraiser, served upon the City of Doral a "Certification of Taxable Value" certifying to the City of Doral its 2012 taxable value; and

WHEREAS, the provisions of Florida Statues Section 200.065 require that within thirty five (35) days of service of the Certification of Taxable Value upon a municipality, said municipality shall be required to furnish to the Property Appraiser of Miami-Dade County the proposed millage rate, the current year roll back rate, and the date, time and place at which a first public hearing will be held to consider the proposed millage rate and tentative budget; and

WHEREAS, The City Council desires to announce the dates of the first and second hearings to the Property Appraiser of Miami-Dade County; and

WHEREAS, The City Council has reviewed the figures supplied by the Property Appraiser of Miami-Dade County and that being otherwise fully advised in the premises;

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AS FOLLOWS:

<u>Section 1</u>. That the proposed millage for the first public hearing is hereby declared to be 2.4376 mills which is \$2.4376 per \$1,000.00 of assessed property within the City of Doral.

Section 2. That the City Council further confirms the current year rolled back rate computed pursuant to section 200.065 F.S., is 2.2430 mills which is \$2.2430 per \$1,000.00 of assessed property within the City of Doral.

<u>Section 3.</u> That the date, time and place of the first and second public hearings are hereby set by the City Council as follows:
