A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, REPEALING RESOLUTION No. 19-244, RELATED TO MEMBERSHIP IN, AND AUTHORIZING PURCHASES FROM, THE INTERLOCAL PURCHASING SYSTEM (TIPS) COOPERATIVE PROGRAM IN NOT TO EXCEED BUDGETED AMOUNTS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, on October 8, 2019, the City of Doral ("City") adopted Resolution No.

19-244, authorizing the City Manager to sign any and all necessary documents requesting membership in TIPS, including an interlocal agreement, for the purchase of "equipment supplies and services in an amount not to exceed budgeted funds" (the "Resolution"); and

WHEREAS, the blanket authority provided by said Resolution has resulted in a

lack of transparency in purchasing; and

WHEREAS, in the interest of transparency and best practices, the City Manager recommends that the Mayor and City Council repeal the Resolution so that individual purchases utilizing TIPS are brought to the City Council for approval when the amount of the purchase exceeds the City Manager's spending authority; and

WHEREAS, the repeal of the Resolution would be effective prospectively (i.e., only apply to future purchases), without effect on past purchases and current contracts for goods and services purchased utilizing TIPS.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. <u>Repeal.</u> Resolution No. 19-244 is hereby repealed. The repeal shall

be of prospective effect only, and shall have no effect on past purchases and current contracts for goods and services purchased utilizing TIPS prior to the effective date of the instant repeal. Unless otherwise provided by law or the City's Code, all active contracts for goods and services may continue until the goods have been delivered and or services entirely rendered.

Section 3. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 4. Effective Date. This Resolution shall become effective immediately upon its adoption.
