## RESOLUTION NO. 12 –58

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE EXTENSION OF THE EXISTING AGREEMENT WITH SUPER LANDSCAPE & MAINTENANCE FOR A PERIOD OF SIX (6) MONTHS FOR THE PROVISION OF CONTINUED PARKS MAINTENANCE SERVICES IN AN AMOUNT NOT TO EXCEED \$125,000.00; AUTHORIZING THE EXTENSION OF THE EXISTING AGREEMENT WITH GREENSOURCE LANDSCAPE & SPORTS TURF, INC. FOR A PERIOD OF SIX (6) MONTHS FOR THE PROVISION OF CONTINUED PARKS MAINTENANCE SERVICES IN AN AMOUNT NOT TO EXCEED \$27,000.00; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral has two existing agreements that provide for parks maintenance services: Super Landscape & Maintenance, Inc. (Super Landscape) and; GreenSource Landscape & Sports Turf, Inc. (GreenSource); and

WHEREAS, an extension of the existing agreement with Super Landscape, which is due to expire on August 8, 2012, for a period of six (6) months in the amount of \$125,000.00 would cover the costs for J.C. Bermudez Park, Morgan Levy Park and Veterans Park as well as temporarily maintain Trails & Tails Park, Downtown Doral Park, and Doral Government Center; and

**WHEREAS,** an extension of the existing agreement with GreenSource, which is due to expire on May 3, 2012, for a period of six (6) months in the amount of \$27,000.00 would cover the costs for maintain Doral Meadow Park; and

WHEREAS, Staff respectfully requests that the City Council authorize the extension of the existing agreement with Super Landscape for a period of six (6) months for the provision of continued parks maintenance services in an amount not to exceed

\$125,000.00 to be transferred from General Government Contingent Reserve to

001.9005.500460; and

WHEREAS, Staff further requests that the City Council authorize the extension of

the existing agreement with GreenSource for a period of six (6) months for the provision

of continued parks maintenance services in an amount not to exceed \$27,000.00.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL

OF THE CITY OF DORAL AS FOLLOWS:

Section 1. The City Council hereby authorizes the extension of the existing

agreement with Super Landscape for a period of six (6) months for the provision of

continued parks maintenance services in an amount not to exceed \$125,000.00 to be

transferred from General Government Contingent Reserve to 001.9005.500460.

Section 2. The City Council further authorizes the extension of the existing

agreement with GreenSource for a period of six (6) months for the provision of

continued parks maintenance services in an amount not to exceed \$27,000.00.

**Section 3.** This Resolution shall become effective immediately upon its adoption.
