The City of Doral authorizes the firm of EAC Consulting Inc. to provide professional engineering design services for the provision of intersection improvements along NW 112 and NW 114 Avenues as recommended in the One-Way Study. The work should be performed in accordance with the contract provisions contained in the Continuing Professional Services Agreement between EAC Consulting Inc. and the City of Doral dated February 26, 2018, and the attached Proposal submitted by your firm for the above referenced project.

**SCOPE OF SERVICES AND SCHEDULE:**

The scope of the project will be as described in the attached proposal from EAC Consulting Inc. dated November 14, 2019 for the design of intersection improvements along NW 112 and NW 114 Avenue. The schedule requires the scoped of work to be completed within 9 months of Notice to Proceed. All limitations of time set forth in this Work Order are of the essence. The performance of services associated with this Work Order will be executed on a Time and Materials basis with a not to exceed amount of \$127,817.08.

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal and revoke the award.


Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated February 26, 2018 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. Work Order is not binding until the City of Doral agrees and approves this Work Order.

**RESOLUTION No. 19-312**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND EAC CONSULTING, TO PROCEED WITH PROFESSIONAL ENGINEERING SERVICES FOR THE DESIGN AND PREPARATION OF CONSTRUCTION PLANS FOR THE INTERSECTION IMPROVEMENTS AT NW 112 AVENUE AND NW 58 STREET, NW 112 AVENUE AND NW 50 STREET, AND NW 114 AVENUE AND NW 58 STREET IN AN AMOUNT NOT TO EXCEED \$127,817.08; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, in 2010 the Doral Transportation Master Plan identified NW 112 Avenue and NW 114 Avenue between NW 41 Street and NW 58 Street as two roadway segments operating each at a poor level of service (LOS) with projected 2015 LOS conditions of F and E respectively; and

**WHEREAS**, the Public Works Department (PWD) collects traffic counts biannually in an effort to determine volumes and types of vehicles using the City's roadway network; and

**WHEREAS**, in 2013 the PWD conducted traffic counts which revealed that the corridor of NW 114 Avenue between NW 41 Street and NW 58 Street was operating at a LOS F; and

**WHEREAS**, in 2015 Miami-Dade County (MDC) passed Resolution R-729-15 for the completion of a study regarding the conversion of certain two-way roadways to one-way roadways as a means to alleviate traffic congestion; and

**WHEREAS**, in line with this MDC Resolution the City explored the feasibility of converting NW 112 Avenue and NW 114 Avenue between NW 41 Street and NW 58 Street to one-way pair roads in order to increase capacity while incorporating complete street elements such as bicycle and transit lanes and on-street parking in order to support

pedestrian, bicycle, and transit use and better serve the community; and

**WHEREAS**, the study evaluated the one-way pair alternative and targeted localized intersection improvements in order to address the deficiencies but due to highly negative socio-economic impact and a negative impact on expected performance the one-way pair option was ranked negatively and the City is intent on moving forward with the targeted localized intersection improvements; and

**WHEREAS**, EAC Consulting is a prequalified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in November 2017; and

**WHEREAS**, City staff respectfully requests that the Mayor and City Council members approve Work Order No. 08 for EAC, a copy of which is attached hereto as Exhibit "A", for the design and preparation of construction plans for the intersection improvements at NW 112 avenue and NW 58 street, NW 112 avenue and NW 50 street, and NW 114 avenue and NW 58 street in an amount not to exceed \$127,817.08; and

**WHEREAS**, funding for this request is available from the Transportation Fund, FY 2018-2019, Account Number No. 101.80005.500650, encumbered under Purchase Number 2019-2050 (\$140,000).

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

**Section 2. Approval.** The Work Order between the City of Doral and EAC Consulting for the engineering services for the design and preparation of construction plans for the intersection improvements at NW 112 avenue and NW 58 street, NW 112 avenue and

NW 50 street, and NW 114 avenue and NW 58 street, in an amount not to exceed of \$127,817.08, a copy which is attached as Exhibit "A", is hereby approved.

**Section 3. Authorization.** The City Manager is authorized to execute the Work Order and expend budgeted funds on behalf of the City in furtherance hereof.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.
