

RESOLUTION No. 21-141

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY'S CODE OF ORDINANCES, AUTHORIZING THE CITY MANAGER TO ADOPT THE EXISTING MIAMI-DADE COUNTY CONTRACT No. RTQ-00914, WHICH WAS COMPETITIVELY ENTERED INTO IN A MANNER SIMILAR TO THAT SET FORTH IN CHAPTER 2, ARTICLE V OF THE CITY'S CODE OF ORDINANCES, FOR THE PURCHASE OF PAINT SUPPLIES AND RELATED ITEMS FOR CITY FACILITIES ON AN AS NEEDED BASIS IN AN AMOUNT NOT TO EXCEED ANNUAL BUDGETED FUNDS; AUTHORIZING THE CITY MANAGER TO ADOPT THE EXISTING MIAMI-DADE COUNTY CONTRACT AND TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, as the City continues to grow, there is a need for the City's facilities to adapt and transform in order to address the needs of a growing staff and ensure that the best possible service is provided to the community; the topics of improving and maintaining City's facilities have been a top priority; and

WHEREAS, the Facilities Maintenance staff repairs, paints, and maintains the aesthetics of the three main City facilities: The Government Center, the Police / Public Works Facility, and the Police Training and Community Center; and

WHEREAS, in an effort to continue to maintain the City's building to the highest quality possible, in a timely and cost-efficient manner, the Public Works Department (PWD) recommends the adoption of the Miami Dade County Contract RTQ-00914; and

WHEREAS, this adoption will allow the City to continue to purchase any necessary paint supplies and related items at a favorable rate; and

WHEREAS, the PWD respectfully requests that the Mayor and the City Council-Members authorize the City Manager to adopt the Miami Dade County Contract No. RTQ-00914, for the term of the contract and any necessary extension periods for the purchase of paint supplies and related items for City Facilities on an as needed basis in an amount not to exceed annual budgeted funds; and

WHEREAS, this contract may be used by all City Departments.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The adoption of the existing Miami Dade County Contract No. RTQ-00914, for the purchase of paint supplies and related items with the approved vendors, and any additional vendor that may be added to the pool for the term of the contract and any extension periods for the provision of paint supplies and related items, in an amount not to exceed annual budgeted funds, is hereby approved.

Section 3. Authorization. The City Manager is authorized to execute the Adoption of the Miami Dade County Contract No. RTQ-00914 and expend budgeted funds on behalf of the City in furtherance hereof.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Mariaca who moved its adoption. The motion was seconded by Councilmember Puig-Corve and upon being put to a vote, the vote was as follows:
