

RESOLUTION NO. 2004-117

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DORAL FLORIDA APPROVING AND AUTHORIZING THE CITY TO EXECUTE MUNICIPAL TRAFFIC CONTROL JURISDICTION AGREEMENTS BETWEEN THE CITY OF DORAL AND ASSOCIATIONS WITH PRIVATE STREETS; AUTHORIZING THE CITY MANAGER TO EXECUTE SAME; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, there are currently owners of real property located within the municipal limits of the City of Doral which have been developed with private streets as opposed to public streets or rights-of-way, and said private streets have been dedicated and deeded to individual Associations; and

WHEREAS, the Associations do not have the power to enact or enforce traffic laws within private street subdivisions nor can they hire others with police power to do same; and

WHEREAS, it is the desire of the City of Doral to afford some measure of traffic enforcement for all residents of the City, wherever they may be situated; and

WHEREAS, at its meeting of December 18, 2004, the City Council of the City of Doral found it to be in the best interests of the City and its citizens to authorize the approval of Municipal Traffic Control Jurisdiction Agreements between the City of Doral and individual Associations; now, therefore

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA:

1. The entering into of individual Municipal Traffic Control Jurisdiction Agreements for subdivisions with private streets and/or rights-of-way is hereby approved. The Agreement will be in substantially the same form as the draft Agreement, attached hereto and incorporated herein as Exhibit "A."

2. The City Manager, upon approval from the City Attorney as to the form of the Agreement, is hereby authorized to execute Agreements referenced in Section 1 above.

3. If any section, part of section, paragraph, clause, phrase or word of this Resolution is declared invalid, the remaining provisions of this Resolution shall not be affected.

4. This Resolution shall become effective upon adoption.

WHEREAS, a motion to approve the Resolution was offered by Councilman DiPietro, who moved its adoption. The motion was seconded by Councilman Van Name and upon being put to a vote, the vote was as follows:
