Per your request, A.D.A. Engineering, Inc. (ADA) is pleased to provide the services identified below for the project entitled "Low Impact Development Master Plan Update" for the City of Doral (City). This Service Order will be an integral part of the General Engineering/Architectural Services (RFQ 2017-21) agreement between the City and ADA. .

#### SCOPE OF WORK

## Task 1: Low Impact Development Ordinance Review and Update

ADA will review the ordinance and provide the City recommendations of suggested changes and refinements to the current ordinance. ADA will provide comments to the City in Word file "Track Change" format.

# Task 2: Low Impact Development Master Plan Report Update

ADA will attend one (1) meeting with City staff to discuss the venue and coordinate a workshop with the development community to obtain input and recommendations to the current LID Master Plan Report. ADA work with the City in participating in a half-day workshop with the development community. The City will advertise and coordinate with developers to maximize workshop attendance.

Based on input from the development community and City staff, ADA will update the current LID Master Plan Report. Below is a summary of the anticipated changes to the Report, for scoping purposed:

- 1. Add up to two (2) new LID best management practices (BMPs).
- 2. Revised the analysis approach for up to two (2) LID BMPs currently included in the LID Master Plan Report.
- 3. Revise report to include new and revised BMPs analysis methodologies.
- Revise sample projects included in the report to incorporate new are revised BMPs.
- 5. Update the hydrologic/hydraulic model used in the sample analyses from ICPRV3 to ICPRV4.

ADA will provide three (3) hardcopies and one electronic copy of the draft LID Master Plan Report Update for the City's review. ADA will attend one (1) meeting with the City to present the finding of the draft updated report. This task will also include attending half-day meeting with commissioners to present the proposed changes to the LID Master Plan Update.

Upon receipt of the City's written review comments and input from Commissioners, ADA will provide the City five (5) hardcopies and one electronic copy of the final LID Master Plan Report.

As part of this task, ADA will attend up to one (1) City Commission meeting to assist the City in addressing any comments from the Commission. It is anticipated that the City will present the updated LID Master Plan Report if needed.
