

RESOLUTION No.18-162

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A BUDGET TRANSFER OF \$24,827.00 FROM PUBLIC WORKS “OTHER CONTRACTUAL SERVICES” ACCOUNT No. 001.80005.500340 TO PUBLIC WORKS “CAPITAL OUTLAY – VEHICLES” ACCOUNT No. 001.80005.500641; APPROVING A PURCHASE PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES OF ONE (1) 2018 FORD F-150 HALF-TON EXTENDED CAB PICKUP TRUCK FOR THE PUBLIC WORKS DEPARTMENT; PURSUANT TO THE EXISTING AGREEMENT BETWEEN DUVAL FORD INC. AND THE FLORIDA SHERIFFS ASSOCIATION AND THE FLORIDA ASSOCIATION OF COUNTIES WHICH WAS COMPETITIVELY ENTERED INTO IN A MANNER SIMILAR TO THAT SET FORTH IN CHAPTER 2, ARTICLE V, OF THE CITY CODE; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY WITH RESPECT TO THE AGREEMENT APPROVED HEREIN; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, as a result of the City of Doral’s (the “City”) growth, the construction of new City Facilities, and the City’s primary goal to provide better services to the community, the PWD Right-of-Way Maintenance Division preliminarily budgeted for the purchase of a Ford F-150 ½ Ton Extended Cab Pickup for Fiscal Year 2018-19; and

WHEREAS, the addition of one (1) new Ford F-150 ½ Ton Extended Cab Pickup is needed for new staff joining the Maintenance Division, additional areas being maintained by the City on County Right of Ways, and for the replacement of aging vehicles in the Maintenance Division fleet; and

WHEREAS, pursuant to section 2-322 of the City Code, Duval Ford holds Contract No. FSA16-VEH15.0 with the Florida Sheriffs Association, which was competitively entered into a manner similar to that set forth in Chapter 2, Article V, of the City of Doral code of ordinances, a copy of which is attached as part of Exhibit “A”, which provides the best prices for the Ford F-150 pickup truck (\$24,827.00); and

WHEREAS, savings were identified in the Public Works “Other Contractual

Services” (Account No. 001.80005.500340) as the Fleet Maintenance shop is not fully operational; and

WHEREAS, the PWD respectfully requests that the City Council authorize a budget transfer of \$24,827.00 from Public Works “Other Contractual Services” (Account No. 001.80005.500340) to the Public Works “Capital Outlay – Vehicles” (Account No. 001.80005.500641) for the purchase of the vehicle.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. Pursuant to Section 2-322 of the City Code of Ordinances, The City Council of the City of Doral hereby authorizes the City Manager to proceed with a budget transfer of \$24,827.00 from “Other Contractual Services” Account (001.80005.500340) to the “Capital Outlay – Vehicles” Account (001.80005.500641) and authorization to purchase a Ford F-150 ½ Ton Extended Cab Pickup Truck from the savings identified in the current Fiscal Year.

Section 3. Authorization. The City Manager is authorized to execute a notice to proceed and expend budgeted funds on the behalf of the City.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Vice Mayor Rodriguez who moved its adoption.
