ORDINANCE #2014-25

AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING THE REZONING OF 3.45± ACRES FOR THE PROPERTY GENERALLY LOCATED ON NW 33RD STREET AND NW 91ST AVENUE, CITY OF DORAL, MIAMI-DADE COUNTY, FLORIDA, FROM INDUSTRIAL COMMERCIAL (IC) TO MULTI-FAMILY-1 RESIDENTIAL (MF-1); PROVIDING FOR EFFECTIVE DATE

WHEREAS, Doral Luxury Patio Homes, LLC ("Applicant"), has requested approval of a rezoning of 3.45 ± acres for properties generally located on NW 33rd Street and NW 91st Avenue, Doral, Florida, from Industrial Commercial (IC) to Multi-Family -1 Residential (MF-1); and

WHEREAS, after careful review and deliberation, staff has determined that this application has complied with the City's Land Development Code and is consistent with the City's Comprehensive Development Master Plan; and

WHEREAS, on July 9, 2014 the City Council held a quasi-judicial hearing and received testimony and evidence related to the Application from the Applicant and other persons and found that the rezoning is consistent with the Comprehensive Development Master Plan and is in the best interest of the residents of Doral;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA THAT:

Section 1. Recitals. The above recitals are true, correct, and incorporated herein by this reference.

Section 2. Approval. The rezoning of 3.45 ± acres for property generally located on NW 91st Avenue and NW 33rd Street, Doral, Florida, from Industrial Commercial (IC) to Multi-Family-1 Residential (MF-1) is hereby approved.

<u>Section 3.</u> <u>Effective Date.</u> This Ordinance shall be effective upon adoption and upon a final non-appealable order approving Ordinance No 2014-24 (the "Comprehensive Plan Amendment Ordinance") if the Comprehensive Plan Amendment Ordinance is not ultimately approved this ordinance shall be void ab initio.
