

RESOLUTION No. 15-77

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING IN ACCORDANCE WITH SECTION 2-322 OF THE CITY CODE OF ORDINANCES, THE PURCHASE OF 10 HARRIS SCAN PORTABLE POLICE RADIOS WITH ACCESSORIES AND PROGRAMMING FROM MIAMI-DADE COUNTY IN AN AMOUNT NOT TO EXCEED \$38,073.20 PURSUANT TO A MIAMI-DADE COUNTY QUOTE; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH MIAMI-DADE COUNTY ON THE BASIS OF SAID TERMS, SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") issued Invitation To Bid #2014-10 (the "ITB") on February 26, 2014 for the purchase of 10 Harris Scan Portable Police Radios, with accessories and programming, with only one (1) responsive bid having been received by the March 19, 2014 deadline; and

WHEREAS, after reviewing the submitted bid and comparing it to the Miami-Dade County pricing for the same equipment, it was determined that the terms of the Miami-Dade County agreement offered better pricing;

WHEREAS, pursuant to Section 2-322 of the City Code, staff has recommended requests that the City Council approve the competitively bid terms of the agreement for Miami-Dade County for the provision of purchasing 10 Harris Scan Portable Police Radios, with accessories and programming in an amount not to exceed \$38,073.20; and

WHEREAS, Staff has further recommended that the City Council authorize the City Manager and the City Attorney to negotiate and enter into an agreement with Miami-Dade County on the basis of said terms.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

Section 1. Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made a part here of by this reference.

Section 2. Approval of Purchase. In accordance with section 2-322 of the City Code of Ordinance, the purchase purchasing 10 Harris Scan Portable Police Radios in an amount not to exceed \$38,073.20, pursuant to the competitively bid terms of the agreement for Miami-Dade County, is hereby approved.

Section 3. Authorization. The City Manager is hereby authorized to negotiate and enter into an agreement with Miami-Dade County on the basis of the foregoing terms, subject to approval by the City Attorney as to form and legal sufficiency.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provision of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Vice Mayor Ruiz who moved its adoption. The motion was seconded by Councilmember Rodriguez and upon being put to a vote, the vote was as follows:
