A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO APPROVE THE PURCHASE AND INSTALLATION OF LICENSE PLATE READERS FOR DORAL CENTRAL PARK FROM MILLENIUM PRODUCTS INC. IN AN AMOUNT NOT TO EXCEED FORTY ONE THOUSAND, SIX HUNDRED FIFTY NINE DOLLARS AND 25/100 (\$41,659.25); UTILIZING GSA CONTRACT No. GS-07F-0031W; PROVIDING FOR AUTHORIZATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, it is essential for the City of Doral (the "City") to ensure the safety and security of our residents, personnel, assets, and sensitive information. As concerns about security continue to grow, it is crucial to enhance our current measures to maintain a secure environment; and

WHEREAS, to bolster our security efforts, the City is installing a CCTV system with strategically placed cameras with the City's Central Park to provide comprehensive surveillance capabilities. This effort is further supported by the installation of license plate reader (LPR) systems at each park entrance; and

WHEREAS, the City of Doral has been utilizing license plate readers since 2015. These systems have been strategically positioned at key intersections and various city parks. They serve as valuable investigative tools for the Doral Police Department, helping to apprehend wanted individuals, address disturbances, and recover stolen vehicles, among other functions. Additionally, the LPR systems have provided assistance to other municipalities.

WHEREAS, Section 2-322 of the City Code of Ordinances provides that the City may enter into contracts procured by other public entities and cooperative purchasing ventures. Accordingly, the City may solicit the services provided by vendors participating in General Services Administration (GSA) Multiple Award Schedule 334220 Security and Protection Products and Service Contract # GS-07F-0031W awarded to Millenium Products Inc; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval and Authorization. The City Manager's Office respectfully requests that the Mayor and City Council Members authorize using GSA Security and Protection Products and Service Contract # GS-07F-0031W to purchase and install four License Plate Reader systems at Doral Central Park. Millenium Products Inc. will provide services in an amount not to exceed forty-one thousand, six hundred fifty nine dollars and 25/100 (\$41,659.25). Funding for this request is available in the current fiscal year and will come from the accounts associated with the Parks Bond Program: 305.90005.500650, 303.90005.500650, 001.90005.500650, 102.90005.500650, 102.90005.500656, and 001.90005.500656.

<u>Section 3.</u> <u>Implementation.</u> The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
