## FIRST AMENDMENT TO WORK ORDER No. 1 BETWEEN THE CITY OF DORAL, FLORIDA AND EXP US SERVICES, INC.

The First Amendment to EXP US Service, Inc. Work Order No. 1, made and entered into this 21st day of April 2025, by and between the City of Doral, Florida, a municipal corporation of the State of Florida ("City") and EXP US Services, Inc. ("Consultant") having its place of business at 201 Alhambra Circle, Suite 800, Coral Gables, FL 33134, for the provision of professional engineering design and permitting services for a new traffic signal at NW 112th Avenue and NW 50th Street, Doral.

WHEREAS, the City of Doral is presently engaged in the design and permitting services of NW 112<sup>th</sup> Avenue and NW 50<sup>th</sup> Street new traffic signal; and

WHEREAS, the awarded design firm's budget will be exhausted prior to design phase completion as a result of for additional design hours required due to Miami Dade County Public (MDC) permitting request; and

WHEREAS, the City of Doral is presently contracted with EXP US Services, Inc. (EXP) to provide professional engineering operational analysis determining the justification for the protected/permissive signal operation and the analysis for the appropriate timing of the intersection; and

WHEREAS, due to the extended scope of work, additional hours are required to ensure that consultant firm services will be conducted up to the design phase closeout; and

WHEREAS, the original cost for the design services approved by the work order was a not-to-exceed amount of \$ 95 384.11; and

WHEREAS, the cost for the provision of design services was increased to a not-exceed amount of \$ 103 596.47 for the additional hours required to provide coverage up to the design phase closeout, with the cost of amended work to be a not-to-exceed amount of \$ 8,212.36.

NOW THEREFORE, in consideration of the mutual covenants set forth in this amendment, the parties agree as follows:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Amendments. The following Sections of the Work Order are hereby amended to read as follows:

## SCOPE OF SERVICES AND SCHEDULE:

The performance of services associated with this Work Order will be executed on a time and material basis with a not to exceed the amount of 95,384.11, 103,596.47.

The scope of the project will be as described in the attached supplemental proposal from EXP for additional work requested by Miami Dade County Department of Public Work during permitting phase and plan review to provide an operational analysis determining the justification for the protected/permissive signal operation and the analysis for the appropriate timing of intersection. The applicable criteria are based on the latest edition of the signalization design manual (Miami Dade County Traffic Signal and signs division), Miami Dade Traffic Control Equipment Standards and Specifications (TCESS), FDOT design manual, Miami Dade County Standards, FDOT traffic Engineering Manual, Manual on Traffic Control devise (MUTCD), National Electric (NEC), and Americans with Disabilities Act (ADA). Analyses and calculations were performed to meet the permit requirements.

The performance of services associated with this Work Order was negotiated and will be executed on a time and material basis not to exceed the amount of \$8,212.36.

EXCEPT AS PROVIDED HEREIN, all other terms and conditions of the Contract dated June 3, 2024, remain in full force, and affect.

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING THE FIRST AMENDMENT TO WORK ORDER No. 1 WITH EXP US SERVICES INC (EXP), TO INCREASE THE AVAILABLE FUNDS FOR PROFESSIONAL SERVICES TO COVER THE COST FOR ADDITIONAL DESIGN AND PERMITTING SERVICES ASSOCIATED WITH THE DESIGN OF THE NEW TRAFFIC SIGNAL AT NW 112 AVENUE AND NW 50 STREET IN AN AMOUNT NOT TO EXCEED EIGHT THOUSAND TWO HUNDRED TWELVE DOLLARS AND THIRTY-SIX CENTS (\$8,212.36); RECOGNIZING THAT EXP US SERVICES INC. IS A CITY OF DORAL PRE-QUALIFIED VENDOR; **AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER** AMENDMENT AND EXPEND BUDGETED FUNDS ON BEHALF OF THE PROVIDING FOR IMPLEMENTATION: PROVIDING FOR INCORPORATION OF RECITALS: AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on September 2024, the City of Doral's (the "City") Public Works Department (the "PWD") executed Work Order No. 1 with EXP US ("EXP") to provide the provision of design and permitting services for the new traffic signal at NW 112<sup>th</sup> Ave and NW 50<sup>th</sup> Street; and

WHEREAS, Work Order No. 1 was approved via Resolution No. 24-215 and executed on a time and material basis in a not to exceed amount of Ninety Five Thousand, Three Hundred Eighty-Four Dollars and 11/100 (\$95,384.11); and

WHEREAS, the Contract between EXP and the City of Doral was procured through the publicly advertised Request for Qualification (RFQ) 2023-08 process to select a pool of pre-qualified Continuing Professional Services firms for "Roadway improvement" projects; and

WHEREAS, this group of eleven (11) firms was approved by the City Council during the March of 2024 Council meeting via Resolution No. 24-54; and

WHEREAS, during the permitting phase with Miami Dade County Public Works

Department (MDC), additional requests were made that require additional professional
services hours and a work order amendment; and

WHEREAS, in order to cover the additional efforts that resulted from the permitting phase with MDC, the PWD requested a proposal and negotiated with EXP the attached supplemental proposal on a time and material basis with a not to exceed amount of Eight Thousand, Two Hundred Twelve Dollars and 36/100 (\$8,212.36) for a new "amended" work order total amount of One Hundred Three Thousand, Five Hundred Ninety Six Dollars and 47/100 (\$103,596.47); and

WHEREAS, the PWD respectfully requests authorization from the Mayor and the City Councilmember to authorize the City Manager to execute the first amendment to Work Order No. 1 enclosed as part of "Exhibit A" for EXP. to provide additional hours for design professional service associated with the new traffic signal at NW 112<sup>th</sup> Ave and NW 50<sup>th</sup> Street; and

WHEREAS, funding for this request is available in the Transportation Fund, "Construction in Progress" Account, Account No. 001.80005.500650.
