A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO REVISE AND EXTEND THE APPROVED SERVICE AGREEMENT WITH UNITED STATES SERVICE INDUSTRIES (USSI) FOR A SIX (6) MONTH PERIOD, FOR THE PROVISION OF CUSTODIAL SERVICES CITYWIDE IN AN AMOUNT NOT TO EXCEED THE DEPARTMENTAL BUDGET FUNDS WHILE A NEW CONTRACT IS PROCURED; ADDING THE OPTION TO INCLUDE PARKS AND RECREATION DEPARTMENT **PROVIDING FACILITIES** THE USSI CONTRACT: TO OF IMPLEMENTATION: **PROVIDING** FOR INCORPORATION RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, RFP No. 2019-47 was issued on December 27, 2019, for the purpose of providing City of Doral (the "City") custodial services for City facilities for an initial contract term of three (3) years with an option to renew for two (2) additional one (1) year; and

WHEREAS, United States Service Industries (USSI) was deemed the highest scorer and most responsive responsible bidder; and on April 22, 2020, the Mayor and the City Council-Members authorized via Resolution 20-29 to enter into a Professional Service Agreement (PSA) with USSI for the provision of Custodial Services citywide on as needed services for an initial period of three (3) years with an option to renew for two (2) one (1) year periods for a possible total of five (5) years; and

WHEREAS, on May 16, 2024, the City Manager executed the final one-year extension of Professional Service Agreement (PSA) with USSI for the provision of Custodial Services citywide on as needed services for the one (1) year period; and

WHEREAS, the Agreement is set to expire on May 20, 2025; and

WHEREAS, City Staff is currently working with the Procurement and Asset Management Department to advertise a new RFP for Custodial services for the City's 3 main facilities (Government Center, Police / Public Works Facility, Police Training & Community Center); and

WHEREAS, during the procurement process the City Manager's Office requested the City's Public Works Department (PWD) to coordinate the inclusion of custodial services for City parks in the custodial services RFP; and

WHEREAS, there is a current need to provide custodial service at all City parks on an as needed basis; and

WHEREAS, the new advertised RFP will include custodial services for Parks facilities on an as needed basis; and

WHEREAS, the PWD respectfully requests authorization for the City Manager to extend the existing contract for an additional six (6) month period, maintaining the same terms, conditions, and pricing of the current contract, while the procurement process for new custodial services is completed, and the new contract is awarded; and

WHEREAS, additionally, the PWD requests the City to provide the City Manager with authority to amend the current USSI contract for custodial services to include City parks; and

WHEREAS, the six-month extension will expire on November 20, 2025; and WHEREAS, the estimated total cost of the extension for the three (3) main

facilities is \$73,618.02; and

WHEREAS, the estimated cost for the Parks facilities is \$5,000.00 per special event and depends on the services needed; and

WHEREAS, funding for this request is available in the Public Works Fund, Account Num. 001.80005.500340, "Contractual Services" for facilities managed by the PWD and benefiting from the USSI custodial services, and in the Parks & Recreation Fund, Account Num. 001.90005.500310, "Recreation Account" for park facilities benefiting from USSI custodial services.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The revised Service Agreement between the City of Doral and USSI for the Custodial services, while maintaining the same terms, conditions, and pricing of the current contract, and the one-time six (6) month extension at an amount not to exceed the Departmental budgeted funds, are hereby approved.

Section 3. Authorization. The City Manager is hereby authorized to execute the proposed extension of the Contract, and is hereby authorized on behalf of the City to amend the City's existing agreement with USSI to include facilities managed by the City's Parks and Recreation Department, and to execute any document(s) necessary to carry out this Contract,

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AWARDING REQUEST FOR PROPOSALS #2019-47 "CUSTODIAL SERVICES FOR CITY FACILITIES"; AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH UNITED STATES SERVICE INDUSTRIES (USSI) FOR THE PROVISION OF CUSTODIAL SERVICES IN AN AMOUNT NOT TO EXCEED BUDGETED FUNDS, FOR AN INITIAL PERIOD OF THREE (3) YEARS WITH AN OPTION TO RENEW FOR TWO (2) ONE (1) YEAR PERIODS FOR A TOTAL OF FIVE (5) YEARS; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, as the City continues to grow, there is a need for the City to adapt and transform in order to provide staff and the community better services; and

WHEREAS, on February 13, 2019, the Mayor and the City Council-Members authorized via Resolution 19-49 to waive competitive bid process and to enter into an agreement with United States Service Industries (USSI) to provide custodial services for a one (1) year period in an amount not to exceed budgeted funds; and

WHEREAS, on February 12, 2020 the Mayor and the City Council-Members authorized via Resolution 20-29 to extend the existing contract agreement with USSI for custodial services at Doral Government Center, Police Department Headquarters, and Doral Police Training and Community Center for six (6) months on a month-to-month basis or until the transition period to the new Custodial Company was completed; and

WHEREAS, RFP No. 2019-47 was issued on December 27, 2019, for the purpose of providing City wide custodial services for City facilities for an initial contract term of three (3) years with an option to renew for two (2) additional one (1) year; and

WHEREAS, a total of Seventeen (17) vendors attended the Mandatory Pre-Proposal Meeting held on January 10, 2010, and nine (9) submittals were received and opened on February 3, 2020, with seven (7) companies meeting the required criteria; and

WHEREAS, United States Service Industries (USSI) was deemed the highest scorer and most responsive responsible bidder; and

WHEREAS, the Public Works Department (PWD) respectfully requests authorization from the Mayor and City Council-Members to authorize the City Manager to enter into a contract agreement with USSI in an amount not to exceed department budgeted funds for custodial services facilities citywide for City of Doral Departments, as needed.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:
