The City of Doral authorizes ADA Engineering, Inc. (ADA) to proceed with the provision of drainage improvement design and permitting phase services for the Vanderbilt area, located between NW 97th Ave and NW 102nd Ave, and from NW 25th Terrace to NW 27th Terrace. Where ADA is part of the pre-qualified pool of consultants selected in accordance with RFQ 2023-08 requirements and approved by the City Council on March 13, 2024, via Resolution 24-54. The work shall be performed in accordance with the contract provisions contained in the Professional Services Agreement between ADA and the City of Doral, dated June 6, 2024 and the proposal submitted by your firm on April 22, 2025 for the above-referenced project.

SCOPE OF SERVICES AND SCHEDULE:

The project scope for the design services will be described in the attached proposal from ADA submitted on April 22, 2025. The schedule requires the work to be completed within Fifteen (15) months from Notice to Proceed (NTP). All limitations of time set forth in this Work Order are of the essence. The performance of services associated with this Work Order will be executed on a time and material basis not to exceed the amount of \$220,975.94

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal and revoke the award.

The work Order incorporates the terms and conditions outlined in the Continuing Services Agreement dated June 12, 2024, between the parties as though fully set forth herein. In the event that any terms or conditions of this work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply.

This Work Order is not binding until the City of Doral agrees and approves this Work Order.

RESOLUTION No. 25-131

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE A WORK ORDER WITH ADA **ENGINEERING PROVIDE PROFESSIONAL** INC., TO **ENGINEERING** TO **DESIGN** STORMWATER SERVICES IMPROVEMENTS AT SUB BASIN F-1, AS IDENTIFIED IN YEAR 2 OF THE STORMRWATER CAPITAL IMPROVEMENT PLAN, IN AN NOT TO EXCEED TWO HUNDRED TWENTY AMOUNT THOUSAND SEVEN HUNDRED NINETY-FIVE DOLLARS AND NINETY-FOUR CENTS (\$220,795.94); AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION: PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on May 12, 2021, the 2021 Stormwater Master Plan and the proposed 5-Year Capital Improvement Plan (CIP) was adopted by the City Council via Resolution No. 21-123 (approved 5-0); and

WHEREAS, the results of the Stormwater Master Plan analysis allowed the City to identify and prioritize general areas where major drainage systems are deficient and define the extent of the deficiencies; and

WHEREAS, in March of 2025, the Public Works Department (PWD) requested a proposal from ADA Engineering Inc (ADA) to provide professional services for the design and permitting phase of stormwater improvements at a portion of Year 2 of the Stormwater Improvements CIP; and

WHEREAS, Sub-basin F-1 Vanderbilt area (NW 25th Terrace from NW 99th Avenue to NW 98th Avenue; NW 26th Street from NW 100th Avenue to NW 98th Avenue, NW 27th Street from NW 102nd Avenue to NW 99th Avenue and NW 27th Terrace from NW 102nd Avenue to NW 99th Avenue and from NW 98th Avenue to NW 97th Avenue); and

WHEREAS, the proposed improvements will help address and minimize flooding from significant rain events that have been observed over time at this location; and

WHEREAS, the implementation of stormwater improvements at locations where flooding is known to occur follows the City's strategic goal of "Public Safety" and ensures that adequate infrastructure is in place to help prevent flooding; and

WHEREAS, the contract between ADA and the City of Doral was procured through the publicly advertised Invitation to Bid (ITB) 2023-08 process to select a pool of pre-qualified Engineering and Architecture firms; and

WHEREAS, this group of eleven (11) firms was approved by the Mayor and City Councilmembers during the March 2024 Council meeting via Resolution No. 24-54 (approved 5-0); and

WHEREAS, the PWD respectfully requests authorization from the Mayor and the City Councilmember to authorize the City Manager to execute Work Order No. 1 enclosed as part of "Exhibit A" for ADA to provide professional design and permitting services for drainage improvements for Sub-basin F-1 located at Vanderbilt area (NW 25th Terrace from NW 99th Avenue to NW 98th Avenue; NW 26th Street from NW 100th Avenue to NW 98th Avenue and NW 27th Terrace from NW 102nd Avenue to NW 99th Avenue to NW 99th Avenue to NW 97th), in an amount not to exceed \$220,795.94; and

WHEREAS, funding for this request is available in the Public Works Stormwater Fund – "Construction in Progress" Account, Account No. 401.80005.500650.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The work Order No. 1 between the City of Doral and ADA to provide professional design and permitting services for drainage improvements for Subbasin F-1 at Vanderbilt area (NW 25th Terrace from NW 99th Avenue to NW 98th Avenue; NW 26th Street from NW 100th Avenue to NW 98th Avenue, NW 27th Street from NW 102nd Avenue to NW 99th Avenue and NW 27th Terrace from NW 102nd Avenue to NW 99th Avenue and from NW 98th Avenue to NW 97th Avenue), in an amount not to exceed \$220,795.94; a copy of which is attached hereto as Exhibit "A", together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney, is hereby approved.

<u>Section 3.</u> <u>Authorization.</u> The City Manager is authorized to execute the work order and expend budgeted funds on behalf of the City.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date</u>. This Resolution shall take effect immediately upon adoption.
