Kimley-Horn and Associates, Inc. ("Kimley-Horn" or "Consultant") is pleased to submit this letter agreement ("Agreement") to the City of Doral ("Client") for providing professional engineering consulting services for the above referenced project. All work under this scope will be in accordance with the terms and conditions of Professional Services Agreement (General Engineering/Architecture Services RFQ 2023-08), between the City of Doral and Kimley-Horn. Our project understanding, scope of services, and fees follow:

PROJECT UNDERSTANDING

The City of Doral is seeking an evaluation of the current traffic calming plan provided in the Section Eight Traffic Calming Study, October 2022 and revised traffic calming recommendations. The current traffic calming plan provided in the *Section Eight Traffic Calming Study*, October 2022 encompasses the area bounded by NW 90th Street to the North, NW 102nd Avenue to the East, NW 74th Street to the South, and NW 107th Avenue to the West. The following Scope of Services summarizes these tasks.

SCOPE OF SERVICES

TASK 1: EVALUATION OF SECTION EIGHT TRAFFIC CALMING STUDY, OCTOBER 2022 AND REVISED TRAFFIC CALMING RECOMMENDATIONS

Task 1A: Traffic Data Gathering

Traffic and speed data collected as part of the *Section Eight Traffic Calming Study*, October 2022 will be gathered and utilized for Task 1. If additional data collection is needed, it can be provided as an additional service.

Task 1B: Evaluation of Current Traffic Calming Plan

A review of the feasibility and spacing of the current traffic calming plan will be performed to evaluate if there are any currently proposed traffic calming measures that are not able to be designed from a geometric perspective or not recommended from a traffic calming perspective. This task may include qualitative or quantitative justification for evaluation of the currently proposed traffic calming measures.

Task 1C: Conceptual Traffic Calming Plan

Based on the outcome of the evaluation of current traffic calming plan, and input from City staff, a revised neighborhood traffic calming plan will be developed for the study area that includes changes to the proposed traffic calming measures. Graphics will be prepared to illustrate the conceptual plan.

Task 1D: Planning Level Opinion of Probable Cost

Traffic calming improvements and enhancements will be evaluated for constructability and a planning level cost estimate will be prepared for the neighborhood traffic calming plan.

Task 1E: Documentation of Findings

A technical letter will be prepared summarizing the data collection, data analysis, and proposed conceptual improvement plan. The report will also include summaries of the meetings conducted during the development of the neighborhood traffic calming plan. The Consultant will update the report and analysis based on one (1) round of the Client's comments. A maximum of ten (10) bound copies will be provided along with an electronic (PDF) copy.

Task 1F: City Meetings

A PowerPoint will be prepared summarizing the analysis and proposed improvement plan. The PowerPoint will be presented at a maximum of two (2) meetings. It is assumed that the meetings will consist of one (1) public workshop, and one (1) city commission meeting. Meeting notes will be prepared by the Consultant. Based on the outcome of the meetings, the conceptual traffic calming plan for the study area may be refined two (2) times.

Task 1G: Miami-Dade County Department of Transportation And Public Works Coordination

One (1) meeting will be held with Miami-Dade County Department of Transportation and Public Works – Traffic Engineering Division to present the study recommendations. The purpose of this meeting is to present the plans to County staff and to answer questions from the County staff regarding the neighborhood traffic calming plans. The conceptual traffic calming plans may be refined a maximum of two (2) times based on County staff comments.

TASK 2: THE CLIENT'S ADDITIONAL SERVICES

Upon your authorization, we will provide any additional services that may be required beyond those described in Task 1. These services may include the following:

- Data collection
- Meetings or Conference Calls
- Services not specifically included within "Scope of Services"

SCHEDULE

Upon receipt of notice to proceed, we will provide our services as expeditiously as practicable to meet a mutually agreed upon schedule not to exceed 12 weeks.

FEE AND BILLING

Kimley-Horn will accomplish the services outlined in Task 01 on a labor fee plus expense basis with estimated labor fee shown below. Labor fee will be billed on an hourly basis according to the standard hourly rate agreed between Kimley-Horn and the Client. Direct expenses, if required, will be billed at 1.15 of the cost. Expenses are in addition to the labor amount. Fees and expenses will be invoiced monthly based upon actual services performed and expenses incurred as of the invoice date. Billing will be due and payable within twenty-five (25) days of receipt of invoice.
