

**AGREEMENT BETWEEN
THE CITY OF DORAL
AND
PORT CONSOLIDATED, INC**

THIS AGREEMENT (hereinafter referred to as the “Agreement”) made up this 1st day of April 2026, between the City of Doral, Florida, a municipal corporation of the State of Florida (hereinafter “City”), having its principal office at 8401 NW 53rd Terrace Doral Florida 33166 and Port Consolidated, Inc., a Florida for-profit Corporation (hereinafter the “Contractor”), having its principal office at , 3141 SE 14th Avenue, Fort Lauderdale, FL 33316.

RECITALS

WHEREAS, the Contractor has an active agreement with the City of Pompano Beach (RFP E-03-22), which was awarded on February 24, 2022 and shall commence on March 15, 2022 and carry through March 14, 2027; and

WHEREAS, the Contract with the City was competitively entered into in a manner consistent with Chapter 2 of the Code of Ordinances of the City; and

WHEREAS, on September 10, 2025, the Mayor and the City Council members adopted Resolution No. 25-226 authorizing the City Manager to enter into an agreement with the Contractor, for the purchase of gasoline and diesel based on the City of Pompano Beach No. RFP E-03-22 in an amount not to exceed departmental budgeted funds.

NOW, THEREFORE, in consideration of the aforementioned recitals, which are incorporated herein and made a part hereof by this reference, and in consideration of the mutual covenants and conditions contained herein, and other good and valuable consideration, the sufficiency of which is acknowledged by the Parties, the Contractor and the City agree as follows:

1. Scope of Services/Deliverables.

1.1 The City agrees to the purchase of gasoline and diesel fuel from the Contractor and the Contractor agrees to sell to the City gasoline and diesel fuel in accordance with the terms and conditions set out in the City of Pompano Beach Contract No. RFP E-03-22.

2. Term and Conditions.

2.1 All terms and conditions of the City of Pompano Beach Contract No. RFP E-03-22 are adopted and incorporated into this Agreement.

- 2.2 Contractor shall comply with the terms and conditions set out in the City of Pompano Beach contract No. RFP E-03-22 and agrees that the city may access the Contractor's services through City of Pompano Beach contract No. RFP E-03-22.
- 2.3 Contractor agrees that with reference to City of Pompano Beach Contract No RFP E-03-22 the City of Doral shall replace "City of Pompano Beach" and or the "City" is referenced. For clarity, it is the intent of the Parties that the City of Doral shall enjoy the same terms and conditions as City of Pompano Beach in the execution and performance of City of Pompano Beach contract No. RFP E-03-22.

3. Incorporation by Reference.

- 3.1 The City of Pompano Beach Contract No. RFP E-03-22, and approved Resolution No. 25-226 are incorporated into this Agreement and attached hereto as Attachment "A".

RESOLUTION No. 25-226

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY'S CODE OF ORDINANCES, AUTHORIZING THE CITY MANAGER TO ADOPT THE CITY OF POMPANO BEACH CONTRACT No. RFP E-03-22, WHICH WAS COMPETITIVELY ENTERED IN A MANNER SIMILAR TO THAT SET FORTH IN CHAPTER 2, ARTICLE V OF THE CITY CODE, AND AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH PORT CONSOLIDATED, INC. FOR THE PURCHASE AND DELIVERY OF UNLEADED GASOLINE AND DIESEL IN AN AMOUNT NOT TO EXCEED ANNUAL BUDGETED FUNDS; AUTHORIZING THE CITY MANAGER TO ADOPT THE CITY OF POMPANO BEACH CONTRACT AND TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in an effort to continue to provide the highest quality service possible, in a timely and cost-efficient manner, the City of Doral (the "City") Public Works Department ("PWD") recommends the adoption of the City of Pompano Beach contract with Port Consolidated, Inc. for the purchase and delivery of Unleaded Gasoline and Diesel fuel; and

- **WHEREAS**, pursuant to Section 2-322 of the City Code, Staff respectfully requests that the Mayor and the City Councilmembers approve the use of the City of Pompano Beach , Contract No. RFP E-03-22 with Port Consolidated Inc, for the term of the contract and any extension periods, which was competitively entered into in a manner similar to that set forth in Chapter 2, Article V, of the City Code, for the provision of Unleaded Gasoline and Diesel, in an amount not to exceed budgeted funds; and

WHEREAS, this adoption will expand the City's list of vendors and will provide redundancies for these services; and

WHEREAS, funds for these services are available in the current fiscal year and

will be budgeted in future fiscal years in the Public Works Fund Account Num. 001.80005.500522 – “Operating Supplies – Vehicles”.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The adoption of the City of Pompano Beach Contract No. RFP E-03-22 with Port Consolidated, Inc. for the term of the contract and any extension periods for the provision of Unleaded Gasoline and Diesel, in an amount not to exceed annual budgeted funds; is hereby approved.

Section 3. Authorization. The City Manager is authorized to execute the agreement and expend budgeted funds on the behalf of the City.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.
