A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO APPROVE THE RENEWAL OF THE CITY'S VIRTUAL PRIVATE NETWORK (VPN) SOLUTION LICENSES FROM CDW-G, IN AN AMOUNT NOT TO EXCEED YEARLY BUDGETED FUNDS, UTILIZING THE TIPS CONTRACT No. 230105; PROVIDING FOR AUTHORIZATION; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral's ("City") VPN solution has been instrumental in ensuring secure remote access for our employees, allowing them to work efficiently and securely from various locations while maintaining the confidentiality and integrity of our data; and

WHEREAS, notably, Section 119.0725 (b), Florida Statutes, creates a public records exemption related to cybersecurity. Specifically, the statute makes confidential and exempt from public record requirements any information related to critical infrastructure, such as the equipment proposed to be purchased by this agenda item; and

WHEREAS, given the sensitive and confidential nature of this purchase to ensure the security of government systems and data, the proposal/contract with the specific product name and details are not included in the published agenda; and

WHEREAS, section 2-322 of the City Code authorizes the City Manager to utilize competitively procured public entity contracts or contracts procured through cooperative purchasing ventures; and

WHEREAS, the renewal is being purchased via TIPS Contract 230105 as required in Sec. 2-322 of the City's Purchasing code; and

WHEREAS, the City Manager's Office respectfully requests that the Mayor and City Council Members authorize the use of TIPS Contract #230105 for the renewal of the City's Virtual Private Network (VPN) solution licenses from CDW-G in an amount not to exceed budgeted funds. Funds are allocated yearly in the IT Maintenance and Repair Account #: 001.22005.500460.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval and Authorization. The City Manager's Office respectfully requests that the Mayor and City Council Members authorize the use of TIPS Contract #230105 for the renewal of the City's Virtual Private Network (VPN) from CDW-G in an amount not to exceed budgeted funds. Funds are allocated yearly in the IT Maintenance and Repair Account #: 001.22005.500460.

<u>Section 3.</u> <u>Implementation.</u> The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.
