A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH LIGHT FX PROS FOR THE PROVISION OF A TWENTY-FIVE (25) MINUTE FIREWORKS SHOW SYNCHRONIZED TO MUSIC FOR THE INDEPENDENCE DAY CELEBRATION EVENT IN THE AMOUNT NOT TO EXCEED SIXTY SIX THOUSAND FIVE HUNDRED DOLLARS AND 00/100 (\$66,500.00); PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, due to the closure of Doral Central Park for construction, the City's annual Independence Day event has been held at Trump National Doral for the past four (4) years.

WHEREAS, given the completion of construction at Central Park, the event will resume at Doral Central Park; and

WHEREAS, Given changes to the park's layout, the Parks & Recreation Department recommends launching fireworks from a marine barge or temporary floating structure in the center of Great Egret Lake. A water-based fireworks show minimizes park area closures by limiting the 350-foot fallout zone to the water; and

WHEREAS, Due to the new launch location, the department recommends approving an agreement through a Request for Quotes (RFQ) process. This approach will help assess specific site requirements and evaluate the new launch setup, allowing the City to issue and advertise a more informed Request for Proposals (RFP) for next year; and

WHEREAS, the Parks & Recreation Department contacted four (4) experienced and qualified firms to submit a proposal for a twenty-five minutes fireworks show

synchronized with music launched from land and water; and

WHEREAS, the City received the following proposals:

- Garden State Fireworks, land-based Fifty Five Thousand Dollars (\$55,000); and
- Starfire Corporation, land-based Fifty Five Thousand Dollars (\$55,000); and
- Alpha Fireworks Displays, land-based Fifty Five Thousand, Five Hundred Dollars (\$55,500); water-based Sixty Seven Thousand Five Hundred Dollars (\$67,500); and
- Light FX Pros, land-based Fifty Two Thousand Five Hundred Dollars (\$52,500); water-based Sixty-Six Thousand Five Hundred Dollars (\$66,500).

WHEREAS, Light FX Pros submitted the best water-based proposal and is also a local vendor; and

WHEREAS, The City Manager respectfully requests approval from the Mayor and City Council to authorize an agreement with Light FX Pros for the provision of a twenty-five (25) minute water-based fireworks show synchronized with music for the City's Independence Day Celebration event in an amount not to exceed \$66,500.00.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval & Authorization. The Mayor and City Council

hereby authorize the City Manager to enter into an agreement with Light FX Pros for the provision of a twenty-five (25) minute water-based fireworks show synchronized with music for the City's Independence Day Celebration event in an amount not to exceed Sixty Six Thousand, Five Hundred Dollars and 00/100 (\$66,500.00).

<u>Section 3.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This resolution shall take effect immediately upon adoption.
