A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING A MUNICIPAL SPONSORSHIP TO AUTISM SPEAKS IN THE AMOUNT OF FIVE HUNDRED DOLLARS AND 00/100 (\$500.00), PURSUANT TO SECTION 2-79 OF THE CITY'S CODE OF ORDINANCES; PROVIDING FOR AUTHORIZATION; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 2-79 of the Code of Ordinances for the City of Doral ("City") governs municipal sponsorships and provides that each councilmember is allotted \$5,000.00 per fiscal year (contingent upon annual city budget approval) to sponsor eligible applicants whose events, services, and programs support the City's vision, mission, and values as set forth in the City's adopted strategic plan and provide a community benefit; and

WHEREAS, the purpose of this section is to establish procedures for all municipal sponsorships, including the disbursement of discretionary funds approved by city councilmembers to sponsor programs, services, events, and charitable and civic organizations that serve a municipal purpose; and

WHEREAS, in a continued commitment to supporting non-profit organizations that embody our core values and significantly contribute to the well-being of our community, Councilwoman Nicole Reinoso proposes sponsorship for Autism Speaks; and

WHEREAS, Autism Speaks is a national non-profit organization dedicated to promoting solutions, across the spectrum and throughout the lifespan, for the needs of individuals with autism and their families through advocacy, support, increasing understanding and acceptance of people with autism, and advancing research into causes and better interventions for autism spectrum disorder; and

WHEREAS, Autism Speaks plays a critical role in advocating for individuals with autism, supporting research, and providing essential services and resources to families affected by autism in our community and beyond; and

WHEREAS, in accordance with Section 2-79 of Municipal Sponsorships, Councilwoman Nicole Reinoso proposes a donation of \$500.00 (Five Hundred Dollars and 00/100) to Autism Speaks; and

WHEREAS, the City Council finds that the proposed municipal sponsorship complies with Section 2-79 of the City's Code of Ordinances and finds that the donation to Autism Speaks serves a municipal purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

<u>Section 2.</u> <u>Approval & Authorization.</u> The Mayor and City Council hereby approve the municipal sponsorship proposed by Councilwoman Nicole Reinoso to Autism Speaks. The City Manager is hereby authorized to expend the budgeted funds.

Section 3. Implementation. The City Manager is hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
