A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, DIRECTING THE CITY ATTORNEY, CITY MANAGER, AND PUBLIC WORKS DIRECTOR TO INITIATE COORDINATION AND DISCUSSIONS WITH THE APPROPRIATE MIAMI-DADE COUNTY DEPARTMENT(S) TO DEVELOP A FORMAL NOTIFICATION SYSTEM FOR UPCOMING ROAD WORK CLOSURES ON MUNICIPAL ROADS WITHIN THE CITY OF DORAL BOUNDARIES. ORDER TO ENHANCE COMMUNICATION AND AWARENESS: PROVIDING FOR AUTHORIZATION: PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral ("City") is committed to providing timely and accurate information to residents regarding traffic disruptions and road work activities that may impact their daily lives; and

WHEREAS, Miami-Dade County frequently conducts road work on municipal roads within the City's boundaries, and the City often receives limited or delayed notice of these activities; and

WHEREAS, lack of sufficient notice impacts the City's ability to inform the public, plan accordingly, and mitigate disruption to traffic, emergency services, and community life; and

WHEREAS, in a continued commitment to improving intergovernmental coordination and enhancing communication with residents, Councilman Rafael Pineyro proposes that the City Attorney, City Manager, and Public Works Director work collaboratively with the appropriate department(s) of Miami-Dade County to establish a formal notification system for upcoming road work closures within the City of Doral; and

WHEREAS, the development of a consistent and timely notification system will allow the City of Doral's Public Works Department to better inform the public and efficiently manage local infrastructure and traffic flow; and

**WHEREAS,** the City Council finds that these actions serve a legitimate municipal purpose and are in the best interest of the residents and businesses of the City of Doral.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA:

Section 1. Authorization. The City of Doral hereby directs the City Attorney, City Manager, and Public Works Director to coordinate with the appropriate Miami-Dade County department(s) to establish a formal, reliable notification system to alert the City of upcoming road work closures affecting municipal roads within the boundaries of the City of Doral.

<u>Section 2</u>. <u>Implementation.</u> The City Manager is hereby directed to take all steps necessary to implement the terms of this Resolution, including initiating discussions, facilitating intergovernmental cooperation, and reporting progress to the City Council.

**Section 3. Effective Date.** This Resolution shall take effect immediately upon its adoption.
