

RESOLUTION No. 25-14

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AWARING INVITATION TO BID #2024-13 “PUBLIC SAFETY UNIFORMS AND ACCESSORIES” TO A PRIMARY AND SECONDARY VENDOR, BASED ON THE LOWEST RESPONSIVE AND RESPONSIBLE VENDORS: GLOBAL TRADING AND UNIFORMS OF DORAL; AUTHORIZING THE CITY MANAGER TO ENTER INTO AGREEMENTS WITH BOTH VENDORS FOR A PERIOD OF THREE (3) YEARS WITH TWO (2) ONE (1) YEAR RENEWALS; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY WITH RESPECT TO THE AGREEMENTS APPROVED HEREIN; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (“City”) Police Department seeks to purchase Public Safety Uniforms and Accessories; and

WHEREAS, the City issued Invitation to Bid (“ITB”) No. 2024-13 for uniforms for public safety officers on July 31, 2024 via electronic notices posted on the City’s website, Vendor Registry, and DemandStar; and

WHEREAS, five (5) firms submitted responsive bids in response to the ITB; and

WHEREAS, upon completion of Procurement staff’s review, a primary and secondary vendor were deemed the lowest responsive and responsible vendors; and

WHEREAS, staff has recommended that the Mayor and the City Councilmembers award the ITB to Global Trading and Uniforms of Doral for the following groups: Groups 1, 2, and 3 to Global Trading (Primary) and Uniforms of Doral (Secondary) and Groups 4, 5, and 6 to Uniforms of Doral (Primary) and Global Trading (Secondary); and

WHEREAS, Staff recommends that the award ITB No. 2024-13 to a primary and secondary vendor based on the lowest responsive, responsible vendors as follows: Award Groups 1, 2, and 3 to Global Trading (Primary) and Uniforms of Doral (Secondary)

and Award Groups 4, 5, and 6 to Uniforms of Doral (Primary) and Global Trading (Secondary); and authorize the City Manager to negotiate and enter into an agreement for the provision of public safety uniforms, accessories, and emergency response supplies for a period of three (3) years with two (2), one (1) year options to renew in an amount not to exceed budgeted funds.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Award. The award of Invitation to Bid No. 2024-13 “Public Safety Uniforms and Accessories” to the lowest responsive and responsible vendors as follows: Award Groups 1, 2, and 3 to Global Trading (Primary) and Uniforms of Doral (Secondary) and Award Groups 4, 5, and 6 to Uniforms of Doral (Primary) and Global Trading (Secondary) are hereby approved. This award, in and of itself, does not vest any rights on any of the named parties.

Section 3. Authorization. The City Manager is authorized to negotiate and enter into agreement with Uniforms of Doral and Global Trading, subject to approval by the City Attorney as to form and legal sufficiency, to provide the Police Department with their public safety uniforms and accessories, not to exceed budgeted amount for a five (5) year term, and on such other terms and conditions as may be in the best interest of the City. The City Manager is further authorized to expend budgeted funds from Operating Supplies account 001.60005.500520 on behalf of the City with respect to the agreement approved herein.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Pineyro who moved its adoption. The motion was seconded by Councilmember Reinoso and upon being put to a vote, the vote was as follows:
