A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO UTILIZE OMNIA PARTNERS COOPERATIVE CONTRACT No. R220503 AND ACCEPT THE PROPOSAL FROM FIELDTURF FOR THE REPLACEMENT OF THE DORAL LEGACY PARK SMALL SOCCER FIELD TURF FOR AN AMOUNT OF ONE HUNDRED THIRTY FOUR THOUSAND FIVE HUNDRED DOLLARS AND 00/100 (\$134,500.00) PLUS A 10% CONTINGENCY FOR AN AMOUNT NOT TO EXCEED ONE HUNDRED FORTY SEVEN THOUSAND NINE HUNDRED AND FIFTY DOLLARS AND 00/100 (\$147,950.00); AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral ("City") is committed to maintaining high standards in recreational facilities and ensuring safety and enjoyment for its residents and visitors; and

WHEREAS, the existing turf at Doral Legacy Park small soccer fields has become brittle and prone to ripping, creating potential tripping hazards that have persisted despite numerous attempts to repair, necessitating the replacement of the turf to ensure safety and usability; and

WHEREAS, Field Turf were the initial installers of the field and have provided warranty repairs over the years and have provided a cooperative pricing bid through Omnia Partners contract.

WHEREAS, pursuant to Sec 2-321 of the City's Code, waiver of competitive bidding procedures is allowed for emergency purchases when there is a threat to public health, welfare or safety as determined under emergency purchase procedures set forth in the Procurement and Purchasing Policy and Procedures Manual.

WHEREAS, staff respectfully requests the approval from the Mayor and City

Councilmembers to authorize the City Manager to accept the proposal submitted by Field Turf, utilizing OMNIA Partners contract #R220503 and enter into an agreement for the replacement of the artificial turf on the two small soccer fields at Doral Legacy Park in an amount not to exceed \$134,500, with an additional 10% contingency resulting in a total not to exceed amount of \$147,950. Funding for this project is allocated in the Park Impact Fee fund, Park Improvements account 102.90005.500634.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The Mayor and City Councilmembers hereby approve the City Manager to accept the proposal submitted by Field Turf, utilizing OMNIA Partners contract #R220503 and enter into an agreement for the replacement of the artificial turf on the two small soccer fields at Doral Legacy Park in an amount not to exceed \$134,500, with an additional 10% contingency resulting in a total not to exceed of \$147,950. Funding for this project is allocated in the Park Impact Fee fund, Park Improvements account 102.90005.500634. The agreement is subject to approval by the City Attorney as to form and legal sufficiency acceptance and on such other terms and conditions as may be appropriate to protect and further the interest of the City. This authorization does not create or confer any rights to Field Turf or any of the other firms.

Section 3. Authorization. The Mayor and City Councilmembers authorize the City Manager to accept the proposal by Field Turf, utilizing OMNIA Partners contract #R220503, and enter into an agreement for the replacement of the artificial turf on the two small soccer fields at Doral Legacy Park in an amount of \$134,500, with an

additional 10% contingency resulting in a total not to exceed of \$147,950. Funding for this project is allocated in the Park Impact Fee fund, Park Improvements account 102.90005.500634.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
