A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT AND USE OF CITY LOGO REQUESTED BY MARIA VALERO TO HOST THE "DORAL DOGGYTON" AT TRAILS AND TAILS PARK LOCATED AT 11645 NW 50 ST, DORAL, FL 33166, ON SUNDAY, OCTOBER 26, 2025. FROM A.M. TO 9:30 A.M.: PROVIDING 7:30 IMPLEMENTATION: **PROVIDING FOR** INCORPORATION OF RECITALS: AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS Maria Valero (the "Applicant") seeks approval from the City of Doral to host the "Doral Doggyton" special event at Trails & Tails Park, and

WHEREAS the purpose of this event is to bring a pet friendly sport activity to our community. This fun event will provide healthy activity for pets and their owners as well as an enjoyable occasion for dog enthusiasts; and

WHEREAS staff recommends that the Mayor and City Council approve the proposed "Doral Doggyton" special event permit to be held Sunday, October 26, 2025, from 7:30 a.m. to 9:30 a.m.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

<u>Section 2. Approval.</u> The special event permit for the "Doral Doggyton" is hereby approved subject to the following conditions:

- 1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
- 2. The Applicant shall be required to have all inspections and approvals prior to the event date.

- Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number to meet the requirements established by the Building Department.
- 4. The Applicant is responsible for providing adequate security at the special event. The police department may require the Applicant to provide and pay for security personnel for crowd control and traffic direction purposes.
- 5. The county fire rescue department may require the Applicant to provide and pay for fire watch personnel.
- 6. The Applicant shall comply with the comments made by the City of Doral Police Department.
- 7. The Applicant shall comply with the comments made by the City of Doral Parks and Recreation Department and pay all applicable fees no later than 14 days in advance of the event.
- 8. The Applicant shall provide to the City of Doral an acceptable certificate of insurance naming the city as an additional insured four weeks prior to the event date.
- 9. The Applicant shall secure a maintenance of traffic (MOT) permit from the City of Doral Public Works Department and/or Miami-Dade County Department of Transportation and Public Works prior to event start date.
- 10. The Applicant shall provide overflow parking arrangements.
- 11. All fees due must be paid within thirty (30) days upon special event approval. Total fees due for Doral Doggyton special event total is Nine Thousand Four Hundred Fifty Nine Dollars and 20/100 (\$9,459.20), which includes Two Thousand, Nine Hundred Eighty Dollars and 14/100 (\$2,980.14) for Police services, Three Hundred Sixty Five Dollars and 00/100 (\$365.00) for Planning and Zoning and Technology fees, and Six Thousand, One Hundred Fourteen Dollars and 06/100 (\$6,114.06) for Park fees and Park security deposit.

<u>Section 3.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
