A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN EXISTING WORK OF PUBLIC ART AT THE DORAL MARKET PLACE PROJECT LOCATED AT 10700 NW 41 STREET, DORAL, FLORIDA, PURSUANT TO CHAPTER 75 OF THE CITY'S LAND DEVELOPMENT CODE; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on June 15, 2015, the City of Doral (the "City") implemented the Public Arts Program to guide the placement of public art in private and public venues in the city; and

WHEREAS, the intent of the City's Public Arts Program is to stimulate the area's cultural environment, heritage, diversity, and create unique community character through public and private artworks integrated into the architecture, infrastructure, and landscape of new developments; and

WHEREAS, TGA SJC Doral Marketplace Owner, LLC (the "Applicant") has elected the option to install artwork within the with Doral Market Place (the "Project") property as specified in Chapter 75, "Public Arts Program" of the City's Land Development Code; and and

WHEREAS, the Applicant and Xavier Coratada (the "Artist") have identified an artistically designed public art initiative composed of a series of hand-painted murals designed to celebrate the interconnected elements of water, light, and life in South Florida. to be installed at the Project located at 10700 NW 41 Street, Doral, Florida 33172; and

WHEREAS, on July 1, 2025, the City's Public Arts Program Committee held a meeting, and a concept proposal of public artwork was presented to the City's Public Arts Program Advisory Board for review; and

WHEREAS, after evaluating the applicant's proposal and considering all testimony, the Public Arts Program Committee voted unanimously (4-0) in favor of approval without conditions; and

WHEREAS, Staff respectfully recommends approval from the Mayor and City Council of the Public Arts Program application submitted by the City of Doral, for the Bridge Point Doral project.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

<u>Section 2. Approval.</u> The Mayor and City Council hereby approve the Public Arts Program application by the City of Doral, for the Doral Marketplace (the "Project"), located at 10700 NW 41 Street, Doral, Florida 33172, attached hereto as "Exhibit A."

<u>Section 3.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

Narrative Statement for Public Art Aqualume and Fruition at Doral Marketplace

by Xavier Cortada

Aqualume and Fruition are two site-specific mural projects that transform the façades of Doral Marketplace into spaces of ecological awareness and visual engagement. Painted across twelve exterior walls spanning three buildings—including a flagship grocery store and several retail storefronts—these works bring environmental themes to life in one of South Florida's fastest-growing commercial districts.

At the heart of the project is *Fruition*, a large-scale corner mural painted across the main façade of Building 100, home to the development's anchor tenant. This highly visible artwork is positioned along NW 41st Street and will be encountered by thousands of drivers, pedestrians, and shoppers each day. Using abstracted, geometric forms of fruits like mangoes, avocados, dragonfruit, and lychees, the mural reflects the relationship between nourishment, growth, and the natural elements—water and light—that sustain them.

On Buildings 200 and 400, the *Aqualume* series unfolds across ten additional walls. These hand-painted works focus on diatoms—microscopic aquatic organisms that produce nearly half the oxygen we breathe. Through vibrant color palettes and dynamic compositions, *Aqualume* invites viewers to consider the unseen systems that support life in South Florida's waterways.

Together, these murals use art to reframe the built environment, connecting the public to the ecosystems that often go unnoticed in the everyday. By incorporating a simple QR code at the site, the project also links viewers to additional information about the ecological subjects depicted in the murals, extending the impact beyond visual appreciation.

Murals have long been a defining feature of Miami's cultural landscape. In continuing this tradition, *Aqualume* and *Fruition* celebrate the city's identity while enhancing the public realm of Doral through a project that is bold, thoughtful, and rooted in place. Aligned with the City of Doral's vision for accessible public art, this mural installation affirms the value of cultural expression in everyday spaces.

Marketplace Doral City Review of Compatibility Aqualume and Fruition at Doral Marketplace by Xavier Cortada

City Review of Compatibility

1. Location and Accessibility

The *Aqualume* and *Fruition* mural project will be prominently displayed on the exterior facades of three buildings within Doral Marketplace, a newly developed retail destination in Doral, Florida. The project consists of hand-painted murals designed by Xavier Cortada, a Florida Artists Hall of Fame inductee with over three decades of experience creating public art that connects people to place and environment.

The murals will be installed across twelve walls:

• Fruition: Anchor tenant at Building 100 (corner installation across 2 walls)

Aqualume: Building 200 (6 walls)Aqualume: Building 400 (4 walls)

These buildings are situated along high-traffic corridors, including NW 41st Street and NW 107th Avenue, offering exceptional visibility to motorists, pedestrians, and shoppers alike. The mural for the anchor tenant is a large, colorful corner mural easily visible to passing vehicles and pedestrians—an expansive and visually engaging composition that draws the eye. The murals face outward toward streets and public walkways, transforming otherwise blank façades into vibrant works of art. This careful siting ensures that the murals contribute not only to the visual character of the development but also to the cultural and experiential quality of the community. By integrating painted murals into a retail plaza, the project enhances public accessibility to art, fostering an environment where art is a natural and inspiring part of everyday life.

2. Tourist-Friendly Locations and Public Areas

Doral is rapidly emerging as one of South Florida's most dynamic communities—a nexus for commerce, culture, and residential life. Placing the *Aqualume* and *Fruition* murals within the Doral Marketplace directly supports the city's mission to create a more vibrant, walkable, and culturally rich public realm.

The murals are located along exterior-facing retail walls, where tourists and locals regularly pass by. These high-visibility locations ensure that the artwork becomes a visual landmark, drawing attention to the site and offering moments of beauty and curiosity throughout the day. The project incorporates **QR code technology** on-site to allow the public to access educational content about the ecological concepts behind the art, expanding its impact and providing a gateway to learning through public engagement.

The *Fruition* mural celebrates the abundance of locally grown fruits—mangoes, avocados, lychee, dragonfruit, oranges, tomatoes—as a visual metaphor for the region's agricultural history and connection to nature. *Aqualume* brings attention to the invisible but essential life forms—diatoms—that live in water and generate half of the Earth's oxygen. Through vibrant color palettes and abstracted natural forms, both mural series highlight the interdependence between human and ecological systems.

These themes make the project highly relatable and engaging, particularly for:

- Tourists seeking cultural enrichment beyond typical Miami destinations
- Families and children, who can enjoy the bright, playful imagery
- Local residents and workers, who gain a new sense of place through daily exposure to public art

Together, these murals help position Doral as a forward-looking city that embraces creativity, environmental awareness, and inclusive access to culture.

3. Appropriateness to the Site and Environmental Conditions

Painted murals are a highly compatible form of public art for the built environment at Doral Marketplace. Murals are a time-honored and culturally significant form of public art, particularly in Miami, where they have long contributed to the region's iconic visual identity. As a bold and visually expansive solution for enhancing architecture, murals offer a highly visible and engaging way to elevate the public realm while working within budgetary and logistical considerations. The wall surfaces provided by the retail buildings serve as ideal canvases—flat, wide, and accessible—allowing the artwork to be seamlessly integrated into the site.

Environmental Adaptation and Material Durability South Florida's climate demands materials that are resilient to heat, humidity, rain, and UV exposure. This project uses:

- Sherwin-Williams Loxon Concrete & Masonry Primer, for sealing and preparing the surface
- Sherwin-Williams Emerald® Exterior Acrylic Latex, chosen for its UV resistance, durability, and fade-proof pigments
- Anti-Graffiti/UV Clear Coat, such as Sher-Clear 1K/2K or Golden MSA Varnish, to ensure long-term protection

This professional-grade material approach ensures the murals remain vibrant and intact for years, with minimal maintenance. The selection of products was guided by the artist's extensive experience creating durable public art throughout Florida's most challenging outdoor environments.

4. Aesthetic Quality and Harmony with the Site

The *Aqualume* and *Fruition* murals reflect South Florida's identity not just in theme but in aesthetic language. Through geometric abstraction and color, the works reference regional

biodiversity in a way that feels fresh, contemporary, and celebratory. Rather than creating literal depictions, the artist magnifies small elements of life—such as microscopic diatoms or fruit cross-sections—into large, expressive visual experiences. This approach encourages viewers to notice the beauty in things often overlooked, and to consider their own connection to nature in an urbanized landscape.

Each mural has been designed with the surrounding architecture and pedestrian experience in mind. The color schemes harmonize with the existing buildings while providing enough contrast to stand out. The scale of the murals complements the height and massing of the retail structures, ensuring the art feels integrated and intentional rather than applied as an afterthought.


Beyond aesthetics, the project contributes to the **emotional tone** of the site. Public art of this kind fosters pride of place and enhances everyday routines. It can transform a quick grocery run or lunch break into a moment of reflection, beauty, or curiosity. For visitors unfamiliar with Doral, the murals offer an immediate sense that this is a place where culture and ecology matter—where even the commercial environment has been thoughtfully considered.

In this way, *Aqualume* and *Fruition* serve as more than decorative additions. They are storytelling tools, placemaking anchors, and cultural assets that help define Doral's urban identity.

Proposal

I will create **Aqualume** and **Fruition**, two vibrant, hand-painted mural projects that celebrate the interconnected forces of **water**, **light**, **and life** in South Florida.

Aqualume

On the exterior of **Buildings 200 and 400**, I will paint **ten murals** (six on Building 200 and four on Building 400) that showcase the beauty of **diatoms**—microscopic aquatic organisms responsible for producing up to half of the oxygen we breathe. Through bold colors and dynamic geometric forms, **Aqualume** magnifies the unseen, revealing the essential role of diatoms in sustaining life while reflecting the movement and energy of South Florida's waters.

Fruition

At **Building 100**, the heart of the commercial space, **Fruition** will transform the **the flagship grocery store's façade** with a **23-foot-high by 50-foot-wide mural** featuring abstracted, geometric representations of **locally grown fruits**—including **oranges**, **lychee**, **starfruit**, **tomatoes**, **dragonfruit**, **avocados**, **and mangoes**—floating across the composition like ripples in water. This large-scale piece highlights the connection between **water**, **growth**, **and nourishment**, evoking the natural rhythms that bring fruit to fruition.



Together, **Aqualume** and **Fruition** turn the built environment into a **vibrant reflection of the natural world**, where microscopic organisms and thriving harvests alike are shaped by the flow of water and light.

Artist's Statement

Water is everything. It falls from above—60 inches of rain drenching South Florida each year. It flows below—recharging the aquifer that sustains us. It surrounds us—stretching east to Biscayne Bay, west through the Everglades, and moving ever southward into Florida Bay. Our land is shaped by water, our lives intertwined with it.


And within that water, too small to see but vital beyond measure, are diatoms. These microscopic organisms capture sunlight and, in doing so, generate up to half of the oxygen we breathe. They are living sparks of the sun's power—floating, drifting, shaping the unseen cycles that sustain us. With every inhale, we are connected to the water, to the light, to them.

In **Aqualume**, ten vibrant murals celebrate the beauty and function of diatoms. Their intricate shapes, illuminated in bold color, remind us of the hidden forces that sustain life. These forms, painted onto the built environment, echo the organic rhythms of South Florida's landscape—fluid, ever-changing, and full of light. By making the smallest things large, we reveal their impact—reminding us that water doesn't just give us life, it gives us the air we breathe.



























Aqualume | B200 Mural 4 (10' X 15' 2")

Artist's Statement

Water and light shape everything we grow. The aquifer holds the memory of past rains, feeding the roots that bring each harvest to life. The sun fuels the plants, turning light into energy, while the land itself, shaped by water over time, provides the foundation for growth. In South Florida, this balance sustains not just our landscapes, but the fruits we cultivate and the communities that rely on them.

Fruition reflects this interconnected cycle. Geometric forms of **locally grown fruits**, including **oranges**, **lychee**, **starfruit**, **tomatoes**, **dragonfruit**, **avocados**, **and mangoes** drift across the mural, carried by unseen currents. They flow like seeds on the wind, echoing the natural rhythms that sustain life. The background, a fluid expanse of movement, evokes the unseen forces—water, time, and ecology—that nourish the land.

This **23-foot-tall mural** transforms the the flagship grocery store's façade into a reminder that we do not live apart from nature, but in constant dialogue with it. Our harvests, our landscapes, and even our own lives are shaped by the elements that sustain us. **Fruition** invites us to recognize this balance, to see the connections that sustain life, and to honor the delicate interplay of **water**, **light**, **and time**.








Fruition | B100 Mural (23' X 50')





Materials, Maintenance and Schedule



Materials: Surface preparation and paints

To ensure the longevity and vibrancy of the murals in the South Florida climate, all materials used will be of the highest professional quality. The following materials have been selected for their durability, resistance to UV radiation, and protection against environmental factors, including graffiti.

Surface Preparation and Primer

Proper surface preparation (by developer) is essential to ensure adhesion and longevity of the paint.

- Sherwin-Williams Loxon Concrete & Masonry Primer/Sealer
 - Type: Acrylic masonry primer
 - Purpose: Enhances adhesion and prevents moisture intrusion
 - Application: Applied in one uniform coat before mural painting

Mural Paints

Sherwin-Williams Emerald® Exterior Acrylic Latex will be used exclusively for its best-in-class durability, fade resistance, and weather protection—ideal for South Florida's harsh climate.

Key Benefits:

- Maximum UV Resistance Advanced pigments prevent fading, keeping colors vibrant.
- Superior Washability Durable finish allows easy cleaning without damage.
- Exceptional Adhesion Bonds well to primed masonry, preventing peeling or flaking.

Materials: Protective Coatings

 - Provides a durable barrier against dirt, moisture, and graffiti
 - Requires an isolation coat for best adhesion

Cleaning and Maintenance

To ensure the mural remains vibrant and clean over time, the following maintenance plan is recommended:

Routine Cleaning:

- Use a soft sponge or cloth with mild soap and water to remove dirt and debris
- Avoid harsh chemical cleaners that may degrade the protective coating

Graffiti Removal:

- If tagged, use a gentle solvent like Sherwin-Williams' Graffiti Remover or a mild citrus-based cleaner designed for graffiti removal
- The anti-graffiti coating allows for easy cleaning without damaging the paint

Annual Inspection & Reapplication:

- Inspect annually for signs of wear or fading
- Reapply UV-protective topcoat every 5-7 years for continued protection

By using these professional-grade materials, the mural will maintain its vibrancy and structural integrity while being protected against environmental factors, UV damage, and vandalism.

- Developer will prep and prime all 10 mural walls in Buildings 200 and 400.
- Developer will prep, prime and paint the background color of the Whole Foods mural in light blue (exact shade to be provided).

- Artist inspects surfaces to ensure they are properly prepared.



- Ensure mural surfaces are fully prepped and dry.
- Schedule workflow (assigning murals to specific weeks for painting).
- Confirm workspace setup (storage, scaffolding access, safety measures).

- Complete all details and final touches on the 23' x 50' mural.
- Apply protective coatings once fully dry.



Xavier Cortada is a Cuban-American artist and a Florida Artists Hall of Fame inductee who has spent over three decades creating public art that inspires community engagement and environmental conservation. The Cuban-American artist has created art at the North and South poles and across 6 continents, including more than 150 public artworks, installations, collaborative murals and socially engaged projects.

Cortada's public art commissions are prominently featured in Florida at locations such as Port Everglades, Jacksonville Beach, the Frost Art Museum, the Florida Turnpike, Florida Botanical Gardens, Curtis Park, and ten Miami-Dade Housing Authority sites. His works also hang permanently in civic spaces, including the Museum of Florida History, the State of Florida Department of State, the commission chambers of the City of Miami, the Upper Keys Government Center, the Village of Pinecrest, and Miami-Dade County Hall. Nationally, his art is part of collections at the Pérez Art Museum Miami, the Whatcom Museum, the Frost Art Museum, and the National Academy of Sciences.

Cortada's work extends beyond Florida to global installations at both the North and South Poles. Through the National Science Foundation, he created *The 150,000-year Journey*, a time-marking piece at the South Pole that launched his broader environmental initiatives. His career began in the 1990s with mural projects addressing social justice issues such as juvenile justice, AIDS, and disabilities. These efforts earned him awards such as the U.S. State Department Millennium International Volunteer Award and the CWLA Champion of Children Award.
