

**RESOLUTION No. 25-211**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY TO ADOPT THE STATE OF GEORGIA DEPARTMENT OF ADMINISTRATIVE SERVICES (DOAS) CONTRACT WITH HOMETOWN TROLLEY FOR THE PURCHASE OF FOUR (4) TROLLEYS; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, The City of Doral (the “City”) Public Works Department (“PWD”) continuously evaluates the Doral Transit system (“DTS”) and provides suggestive improvements to meet increasing passenger demand and maintain service reliability; and

**WHEREAS**, the City’s trolley fleet currently consists of twenty (20) vehicles operating along four (4) routes, with twelve (12) vehicles in service during weekday peak hours and eight (8) vehicles held in reserve; and

**WHEREAS**, the city has an aging fleet and experiences service downtime due to maintenance issues and “Vehicle Regen”. Vehicle Regen is a mechanical process that involves the use of a legally mandated diesel particulate filter (DPF) to help keep the engine run smoothly. Vehicles are inoperative during the “Vehicle Regen” process.

**WHEREAS**, in February 2024 the City Council adopted Resolution No. 24-29 authorizing the purchase of eight (8) rear engine trolleys; and

**WHEREAS**, six (6) of those eight (8) vehicles have been delivered as of July 2024, with the remaining two (2) expected by the end of August 2025; and

**WHEREAS**, For Fiscal year 2024-25, the City budgeted One Million, Six Hundred Eighty Five Thousand Dollars and 00/100 (\$1,685,000.00) in the CITT Fund for the purchase of an additional five (5) vehicles; and

**WHEREAS**, due to the rising costs of trolley vehicles, budgeted funding will only provide for the purchase of four (4) vehicles; and

**WHEREAS**, the PWD respectfully requests authorization to adopt the State of Georgia DOAS Contract (SWC) #: 99999-SPD-SPD0000212-0002 for the purchase four (4) new Hometown Trolley 34' Freightliner 6.7L Diesel trolley; and

**WHEREAS**, this contract provides the best prices on the market and allows the City of Doral to continue to purchase trolleys that meet the City's needs and requirements.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

**Section 2. Approval.** The City Council approves the City's Public Works Department to access the State of Georgia DOAS Statewide Contract, Contract No. 99999-SPD-SPD0000212-0002, for the purchase of four (4) Replica Trolley Buses, in an amount not to exceed budgeted funds, is hereby approved.

**Section 3. Authorization.** The City Manager is authorized to utilize the State of Georgia DOAS Contract and expend budgeted funds for the purchase of four (4) trolleys.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall become effective immediately upon its adoption.

The foregoing Resolution was offered by Councilmember Pineyro who moved its adoption. The motion was seconded by Councilmember Cabral and upon being put to a vote, the vote was as follows:
