A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING A MUNICIPAL SPONSORSHIP TO COMMUNITAS DEI ASSOCIATION (CDEI MIAMI) IN THE AMOUNT OF NINE HUNDRED TWENTY-FIVE DOLLARS AND 00/100 (\$925.00), PURSUANT TO SECTION 2-79 OF THE CITY'S CODE OF ORDINANCES; PROVIDING FOR AUTHORIZATION; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS Section 2-79 of the Code of Ordinances for the City of Doral governs municipal sponsorships and provides that each Council member is allotted \$5,000 per fiscal year to sponsor special events for eligible applicants whose events and programs support the City's mission and provide a community benefit; and

WHEREAS Communitas Dei Association (CDEI Miami) is a nonprofit umbrella organization dedicated to supporting six exceptional programs that create better opportunities for Venezuelan children and families through education, integration, and community empowerment; and

WHEREAS CDEI Miami provides essential resources, educational support, and materials that allow families to successfully adapt, integrate, and thrive in their new communities; and

WHEREAS The efforts of CDEI Miami align with the City of Doral's mission to enhance the welfare and quality of life for all residents; and

WHEREAS The sponsorship will aid CDEI Miami in continuing its valuable programs and services within the community.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA:

Section 1. Authorization. The City of Doral hereby authorizes municipal sponsorships in the amounts of Nine Hundred Twenty-Five Dollars (\$925.00) to Communitas Dei Association (CDEI Miami) pursuant to Section 2-79 of the City's Code of Ordinances. This funding supports the organization's initiatives to provide essential resources and programs to benefit children and families.

<u>Section 2.</u> <u>Implementation.</u> The City Manager is hereby directed to take all steps necessary to implement the terms of this Resolution including the disbursement of funds consistent with the City's fiscal policies.

Section 3. Effective Date. This Resolution shall take effect immediately upon its adoption.
