A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-321 OF THE CITY'S CODE OF ORDINANCES, WAIVING THE COMPETITIVE BID PROCESS AND AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT AGREEMENT WITH THYSSENKRUPP ELEVATORS, FOR ELEVATOR MAINTENANCE SERVICES IN THE GOVERNMENT CENTER AND THE GOVERNMENT CENTER PARKING GARAGE FOR A FIVE (5) YEAR PERIOD IN AN AMOUNT NOT TO EXCEED BUDGETED FUNDS; AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT AND TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, ThyssenKrupp Elevator is the original manufacturer and installer of the five (5) elevators in the Doral Government Center and Parking Garage; and

WHEREAS, the Public Works Department (PWD) believes that it is in the best interest of the City of Doral to establish an agreement to schedule regular and preventative maintenance, repairs, and monitoring services for these elevators in order to guarantee the reliable performance of this equipment; and

WHEREAS, ThyssenKrupp is the sole authorized equipment manufacturer, representative, and distributor for the original equipment manufacturer (OEM) parts, proprietary software and hardware for ThyssenKrupp equipment installed; It is also the only company that can provide factory trained mechanics and engineers, authorized service, repairs and maintenance for the Government Center elevators; and

WHEREAS, the Public Works Department (PWD) respectfully requests the waiving of the competitive bid process, pursuant to section 2-321 of the City of Doral Code of Ordinances, and respectfully requests authorization from the Mayor and City

Council members for the City Manager to enter into a contract with Thyssenkrupp Elevators for the provision of Elevators Maintenance and Repairs for the Government Center and the Parking Garage; and

WHEREAS, funds for these services were budgeted in Fiscal Year 2024-2025 in General Government Fund Account Number 001.50005.500460 – Repairs and Maintenance.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The Mayor and the City Council of the City of Doral hereby waives the competitive procurement process and authorizes the City Manager to enter into a contract agreement with ThyssenKrupp Elevators for the provision of elevator maintenance for a period of five (5) years in an amount not to exceed budget funds..

<u>Section 3.</u> <u>Authorization.</u> The City Manager is authorized to execute the Contract Agreement and expend budgeted funds on behalf of the City in furtherance hereof.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
