A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE AWARD OF REQUEST FOR PROPOSALS RFP #2025-09 "SWIM TEAM MANAGEMENT SERVICES" TO AB SWIM LLC; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH AB SWIM LLC FOR THE DEVELOPMENT, ADMINISTRATION, AND EXECUTION OF A YEAR-ROUND COMPETITIVE SWIM TEAM PROGRAM AT THE DORAL CENTRAL PARK AQUATIC CENTER; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR THE EXPENDITURE OF BUDGETED FUNDS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, The City of Doral, through its Parks and Recreation Department and the Procurement and Asset Management Department, issued RFP No. 2025-09 on June 4, 2025, seeking proposals from qualified firms to provide Swim Team Management Services at the Doral Central Park Aquatic Center; and

WHEREAS, The Evaluation Committee recommended the award of RFP No. 2025-09 to AB Swim LLC, and the City Manager concurs with this recommendation and seeks Council approval to execute an agreement; accordingly, and

WHEREAS, The proposed agreement will require AB Swim LLC to develop, administer, and operate a year-round competitive swim team program in accordance with USA Swimming and Florida Gold Coast Swimming standards, branded as the City of Doral Swim Team.

WHEREAS, pursuant to Sec. 2-323(5) of the City Code, the City Manager's Office respectfully requests approval from the Mayor and City Councilmembers to authorize the City Manager to negotiate and enter into negotiations with AB Swim LLC, LLC. for a period of three (3) years with one (1) two (2) year renewal term for a total of five (5) years under the same terms and conditions.

<u>Section 2.</u> <u>Approval & Authorization</u>. The Mayor and City Council hereby approve the award of RFP No. 2025-09 to AB Swim LLC. The City Manager is authorized to negotiate and enter into an agreement with AB Swim LLC, subject to legal review, for Swim Team Management Services at the Doral Central Park Aquatic Center.

Section 3. Implementation. The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This resolution shall take effect immediately upon adoption.
