A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY'S CODE OF ORDINANCES, AUTHORIZING THE CITY MANAGER TO ADOPT THE CITY OF POMPANO BEACH CONTRACT No. RFP E-03-22, WHICH WAS COMPETITIVELY ENTERED IN A MANNER SIMILAR TO THAT SET FORTH IN CHAPTER 2, ARTICLE V OF THE CITY CODE, AND AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH PORT CONSOLIDATED, INC. FOR THE PURCHASE AND DELIVERY OF UNLEADED GASOLINE AND DIESEL IN AN AMOUNT NOT TO EXCEED ANNUAL BUDGETED FUNDS; AUTHORIZING THE CITY MANAGER TO ADOPT THE CITY OF POMPANO BEACH CONTRACT AND TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in an effort to continue to provide the highest quality service possible, in a timely and cost-efficient manner, the City of Doral (the "City") Public Works Department ("PWD") recommends the adoption of the City of Pompano Beach contract with Port Consolidated, Inc. for the purchase and delivery of Unleaded Gasoline and Diesel fuel; and

WHEREAS, pursuant to Section 2-322 of the City Code, Staff respectfully requests that the Mayor and the City Councilmembers approve the use of the City of Pompano Beach, Contract No. RFP E-03-22 with Port Consolidated Inc, for the term of the contract and any extension periods, which was competitively entered into in a manner similar to that set forth in Chapter 2, Article V, of the City Code, for the provision of Unleaded Gasoline and Diesel, in an amount not to exceed budgeted funds; and

WHEREAS, this adoption will expand the City's list of vendors and will provide redundancies for these services; and

WHEREAS, funds for these services are available in the current fiscal year and

will be budgeted in future fiscal years in the Public Works Fund Account Num. 001.80005.500522 – "Operating Supplies – Vehicles".

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The adoption of the City of Pompano Beach Contract No. RFP E-03-22 with Port Consolidated, Inc. for the term of the contract and any extension periods for the provision of Unleaded Gasoline and Diesel, in an amount not to exceed annual budgeted funds; is hereby approved.

Section 3. Authorization. The City Manager is authorized to execute the agreement and expend budgeted funds on the behalf of the City.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
