WHEREAS, the City of Doral ("City") seeks to continually enhance programs and services for its senior residents through innovative approaches; and

WHEREAS, the City's Silver Club program provides social, recreational, and educational opportunities for senior residents, and updated identification cards will further enhance participation and engagement; and

WHEREAS, the new identification cards will include a photo and QR code linking members to a monthly updated webpage featuring a calendar of Silver Club events and a list of participating local businesses providing senior discounts; and

WHEREAS, the City Council finds that this initiative will support community engagement, increase access to benefits, and align with the City's commitment to improving services for senior residents.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

<u>Section 2.</u> Authorization. The Mayor and City Council hereby direct the City Manager and the Parks and Recreation Department to design, create, and issue updated

Silver Club identification cards with the specified features. The QR code shall be maintained and updated monthly by City staff.

Section 3. Implementation. The City Manager is hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.
