

**RESOLUTION No. 25-241**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO ACCESS TIPS CONTRACT 230105 TECHNOLOGY SOLUTIONS, PRODUCTS, AND SERVICES PURSUANT TO SECTION 2-322 OF THE CITY OF DORAL CODE OF ORDINANCES, FOR THE RENEWAL OF VIRTUALIZATION AND SERVER INFRASTRUCTURE SOFTWARE SUBSCRIPTION THROUGH A MULTI-YEAR AGREEMENT PAID ANNUALLY WITH GOVCONNECTION INC; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City relies on virtualization and server infrastructure software as a central platform for managing and monitoring its virtualized data center environment; and

**WHEREAS**, the City currently operates over a hundred virtual machines across its data centers, which are essential for delivering applications, supporting departments, and ensuring continuity of operations; and

**WHEREAS**, this software provides critical features including efficient resource management, high availability, backup restoration, and strong security capabilities, thereby minimizing downtime and safeguarding sensitive information; and

**WHEREAS**, these technologies have consistently demonstrated stability and reliability, optimizing performance, reducing hardware costs, and supporting the City's IT modernization initiatives; and

**WHEREAS**, notably, Section 119.0725 (b), Florida Statutes, creates a public records exemption related to cybersecurity. Specifically, the statute makes any information related to critical infrastructure such as this confidential and exempt from

public record requirements. In addition to the public records exemption, any portion of a meeting that might reveal such information is exempt from public meeting requirements. See Section 119.0725(3), Florida Statutes; and

**WHEREAS**, Section 2-322 of the City Code of Ordinances provides that the Council may enter into contracts procured by other public entities and cooperative purchasing ventures. Accordingly, the City may solicit the goods and services provided by vendors participating in TIPS contract 230105 Technology Solutions, Products, and Services; and

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** The City Manager's Office respectfully requests that the Mayor and City Council Members authorize using TIPS contract 230105 Technology Solutions, Products, and Services to renew virtualization and server infrastructure software subscription through a multi-year agreement paid annually with GovConnection Inc., not to exceed budgeted funds. Funds allocated in the IT Maintenance Account # 001.22005.500460.

**Section 3. Implementation.** The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 4. Effective Date.** This Resolution shall take effect immediately upon adoption.
