A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE AWARD OF INVITATION TO BID ITB #2025-11 "PURCHASE AND DELIVERY OF LIQUID SODIUM HYPOCHLORITE SOLUTION" TO HAWKINS, INC. FOR THE DORAL CENTRAL PARK AQUATIC CENTER; AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH HAWKINS, INC. FOR AN INITIAL TERM OF THREE (3) YEARS, WITH TWO (2) ONE-YEAR RENEWAL OPTIONS, SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral ("City") issued Invitation to Bid (ITB) No. 2025-11 for the purchase and delivery of Liquid Sodium Hypochlorite solution; and

WHEREAS, four bids were received, of which two were "No Bids" and two were responsive and responsible submissions; and

WHEREAS, Hawkins, Inc. submitted the lowest responsive and responsible bid at a price of Two Dollars and 65/100 (\$2.65) per gallon; and

WHEREAS, staff recommends awarding ITB No. 2025-11 to Hawkins, Inc. for a three (3) year term with two (2), one (1) year renewal options; and

WHEREAS, staff respectfully requests the approval from the Mayor and City Councilmembers to award ITB No. 2025-11 for the purchase and delivery of Liquid Sodium Hypochlorite Solution for the Doral Central Park Aquatic Center to Hawkins, Inc., the lowest responsive and responsible bidder, at a rate of \$2.65 per gallon, to be used as needed for an estimated budgeted amount of One Hundred Thousand Dollars (\$100,000.00); and

WHEREAS, funding for this item is available in the Parks and Recreation Contractual Services Account No. 001.90005.500340.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

<u>Section 2.</u> <u>Approval.</u> The City Council hereby approves the award of Invitation to Bid (ITB) No. 2025-11 for the purchase and delivery of Liquid Sodium Hypochlorite Solution for the Doral Central Park Aquatic Center to Hawkins, Inc., the lowest responsive and responsible bidder, at a rate of \$2.65 per gallon.

Section 3. Authorization. The Mayor and City Councilmembers authorize the City Manager to enter into an agreement with Hawkins, Inc. for the purchase and delivery of Liquid Sodium Hypochlorite Solution, to be used as needed in an amount estimated at approximately \$100,000.00. Funding is available in the Parks and Recreation Contractual Services Account No. 001.90005.500340.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date</u>. This Resolution shall take effect immediately upon adoption.
