

RESOLUTION No. 25-25

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AWARDED INVITATION TO BID #2024-29 “SOLID WASTE DISPOSAL AND RECYCLING SERVICES” TO WASTE PRO OF FLORIDA; AUTHORIZING THE CITY MANAGER TO ENTER INTO A SERVICE AGREEMENT WITH WASTE PRO OF FLORIDA, FOR AN INITIAL THREE (3) YEAR PERIOD WITH AN ADDITIONAL ONE-TIME OPTIONAL TWO (2) YEARS EXTENSION IN AN AMOUNT NOT TO EXCEED BUDGETED FUNDS; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY WITH RESPECT TO THE AGREEMENT APPROVED HEREIN; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (“City”) Public Works Department (PWD), Parks and Recreation Department (PRD), and Procurement and Asset Management Division prepared Invitation to Bid (ITB) No. 2024-29 for the provision of solid waste disposal and recycling services to replace the current contract that is scheduled to expire on February 11, 2025, and

WHEREAS, on November 6, 2024, the City of Doral issued ITB No. 2024-29 inviting all qualified and experienced firms to submit bids for the provision of Solid Waste Disposal and Recycling Services; and

WHEREAS, the Procurement and Asset Management Division held a publicly noticed non-mandatory pre-bid conference on November 13, 2024, and

WHEREAS, on December 4, 2024, the City received and opened four (4) proposals from the following respondents: 39 Environmental, LLC, Great Waste and Recycling, LLC, Waste Management, and Waste Pro of Florida, Inc.; and

WHEREAS, the submittals were reviewed by subject matter expert staff; and

WHEREAS, responsiveness, responsibility and references were reviewed for the apparent lowest, responsive and responsible bidder, Waste Pro of Florida, Inc.; and

WHEREAS, City Staff respectfully requests authorization for the City Manager to enter into a Service Agreement with Waste Pro of Florida for the solid waste and recycling services for the three main facilities (Government Center, Police / Public Works Facility, Police Training and Community Center) and all City parks, for an three (3) years with a one-time optional extension of two (2) years; and

WHEREAS, funding to cover the cost for this expense is budgeted in Fiscal Year 2024-2025, in the PWD and in the PRD “Contractual Services” Accounts, Accounts Num. 001.80005.500340, 001.50005.500340 and 001.90005.500340.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The Service Agreement between the City of Doral and Waste Pro of Florida for the solid waste and recycling services for a three (3) year period with a one-time optional two (2) years extension at an amount not to exceed the PWD and PRD Departmental budgeted funds is hereby approved.

Section 3. Authorization. The City Manager is hereby authorized to execute the Agreement, attached hereto as Exhibit “A”, and to expend budgeted funds on behalf of the City in an amount not to exceed budgeted funds.

Section 4. Implementation. The City Manager and City Attorney are hereby authorized to take such action as may be necessary to implement the purpose and the provisions of this resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Pineyro who moved its adoption. The motion was seconded by Councilmember Reinoso and upon being put to a vote, the vote was as follows:
