

RESOLUTION No. 25-252

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO ADOPT THE CITY OF NORTH MIAMI CONTRACT WITH BIDERA, LLC TO PHASE-OUT THE VEHICLES, EXECUTE THE VEHICLE TITLES, AND PROCEED WITH THE AUCTIONING OF THE VEHICLES INCLUDED IN EXHIBIT "A"; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, The Public Works Department (PWD) respectfully requests authorization from the Mayor and the City Councilmembers to adopt the City of North Miami contract RFP number 29-24-25 with Bidera, LLC, for surplus auction services, and authorize the City Manager to phase-out the vehicles, execute the vehicles' titles, and proceed with the auctioning of the vehicles included in Exhibit A; and

WHEREAS, to achieve the optimal use of every vehicle and piece of equipment, the PWD recommends the adequate time to phase out a vehicle or piece of equipment, based on the life cycle of each, with the understanding of the needs of each City Department; and

WHEREAS, this recommendation is based on a life cycle analysis, industry standards, vehicle age, mileage, engine hours, maintenance costs, and each City Department's vehicle needs; and

WHEREAS, all revenue funds received from the sale of surplus items will be deposited into the City's 'Miscellaneous Revenue Account', Account No. 001.50005.369100; and

NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The adoption of the City of North Miami contract RFP number 29-24-25 with Bidera, LLC, for surplus auction services, and the phase-out and auction of the vehicles included in Exhibit “A”, are hereby approved.

Section 3. Authorization. The City Manager is authorized to execute the title documents of each vehicle in Exhibit “A” and proceed with the auctioning of the vehicles on behalf of the City.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Reinoso who moved its adoption. The motion was seconded by Councilmember Pineyro and upon being put to a vote, the vote was as follows:


