

RESOLUTION No. 25-258

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING MUNICIPAL SPONSORSHIPS TO VENEZUELA AWARENESS FOUNDATION IN THE AMOUNT OF FIVE HUNDRED DOLLARS AND 00/100 (\$500.00); VIRTUTEM POPULO, INC IN THE AMOUNT OF FIVE HUNDRED DOLLARS AND 00/100 (\$500.00); AND MONSEÑOR FELIPE BELLO FOUNDATION, INC IN THE AMOUNT OF ONE THOUSAND DOLLARS AND 00/100 (\$1,000.00); PURSUANT TO SECTION 2-79 OF THE CITY'S CODE OF ORDINANCES; PROVIDING FOR AUTHORIZATION; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 2-79 of the Code of Ordinances for the City of Doral governs municipal sponsorships and provides that each Council member is allotted \$5,000 per fiscal year to sponsor special events for eligible applicants whose events and programs support the city's mission and provide a community benefit; and

WHEREAS, the Venezuela Awareness Foundation is committed to defending human rights and assisting immigrants in South Florida, offering legal orientations and humanitarian support for recently arrived families; and

WHEREAS, Virtutem Populo, a youth development organization, fosters leadership skills, civic engagement, and academic achievement among young residents through workshops and mentorships held in schools and public venues; and

WHEREAS, Monsenor Felipe Bello Foundation, organizes charitable campaigns to support children and families with limited resources, especially during the holiday season, distributing toys and essential items to the people in need; and

WHEREAS, these nonprofit organizations' efforts align with the City of Doral's mission to enhance the welfare and quality of life for all residents; and

WHEREAS, the sponsorships will aid these organizations in continuing their vital work within the community;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA:

Section 1. Authorization. The City of Doral hereby authorizes municipal sponsorships in the amounts of:

- Venezuela Awareness Foundation – \$500.00
- Virtutem Populo – \$500.00
- Monsenor Felipe Bello Foundation, – \$1,000.00

pursuant to Section 2-79 of the City's Code of Ordinances.

Section 2. Implementation. The City Manager is hereby directed to take all steps necessary to implement the terms of this Resolution including the disbursement of funds consistent with the City's fiscal policies.

Section 3. Effective Date. This Resolution shall take effect immediately upon its adoption.

The Prime Sponsor of the foregoing resolution is Vice Mayor Digna Cabral.
