A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY'S CODE OF ORDINANCES, AUTHORIZING THE CITY MANAGER TO ACCESS OMNIA CONTRACT No. R220702 FOR THE MIGRATION OF THE CITY VIDEO MANAGEMENT SYSTEM AND LICENSES WITH INTEGRATED SERVICES SYSTEMS (ISS); AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") currently operates two separate video management systems, one of which is outdated and no longer supported by the vendor; and

WHEREAS, to ensure continued reliability, security, and maintainability, the cameras connected to the unsupported system will be migrated to the existing platform currently in use by the City at road intersections and the newly implemented park camera system; and

WHEREAS, consolidating both systems under a single video management solution will enhance operational efficiency and simplify system administration; and

WHEREAS, forgoing a migration to an upgraded video management solution poses operational challenges, due to limited compatibility with modern hardware and the lack of software updates that will ensure continued use; and

WHEREAS, by migrating all City facility cameras to the supported platform, the City will benefit from an improved system stability, centralized management, and streamlined licensing; and

WHEREAS, platform consolidation offers enhanced scalability, secure remote access, advanced analytics, and improved video retention and sharing capabilities; and

WHEREAS, these features will strengthen the City's ability to manage video assets across departments efficiently, and support both daily operations and critical incident response; and

WHEREAS, Florida Statutes §§ 119.0725 (b) and 282.318 establishes the confidentiality of documents that exposes cybersecurity infrastructure and provides for a public records exemption; and

WHEREAS, additionally, the Statutes protect the confidentiality and provide a public record exemption for any portion of a public meeting that might reveal information regarding the City's cybersecurity infrastructure; and

WHEREAS, City staff recommends that the City's Mayor and Council Members authorize the Manager to access OMNIA Contract R220702 to allow for the migration of the City's video management system and licenses with the integrated services systems (ISS); and

WHEREAS, pursuant to Section 2-322 of the City's Code of Ordinances, the City is authorized to purchase supplies, materials, equipment, and contractual services which are the subject of contracts through cooperative purchasing ventures, where the best interest of the City would be served thereby.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval and Authorization. In order to effectuate the migration of the City's video management system and licenses with Integrated Services Systems, the City Manager and City Attorney are authorized to take all necessary action to access OMNIA Contract R220702, and execute and amendments, addendums, or any other document necessary for the City to access the Integrated Services Systems.

Section 3. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the provisions of this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
