

**RESOLUTION No. 25-269**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING A MUNICIPAL SPONSORSHIP TO DUE TO ARTS, INC. IN THE AMOUNT OF TWO THOUSAND DOLLARS AND 00/100 (\$2,000.00), PURSUANT TO SECTION 2-79 OF THE CITY'S CODE OF ORDINANCES; PROVIDING FOR AUTHORIZATION; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Section 2-79 of the Code of Ordinances for the City of Doral ("City") governs municipal sponsorships and provides that each councilmember is allotted \$5,000.00 per fiscal year (contingent upon annual city budget approval), to sponsor eligible applicants whose events, services, and programs support the City's vision, mission, and values as set forth in the City's adopted strategic plan and provide a community benefit; and

**WHEREAS**, the purpose of this section is to establish procedures for all municipal sponsorships including the disbursement of discretionary funds approved by City's councilmembers to sponsor programs, services, events, and charitable and civic organizations that serve a municipal purpose; and

**WHEREAS**, in a continued commitment to supporting nonprofit organizations that embody our core values and significantly contribute to the well-being of our community, Councilwoman Maureen Porras proposes a sponsorship to support Due to Arts, Inc; and

**WHEREAS**, this organization aligns with our established vision, mission, and values but also demonstrate a commitment to making a substantial impact in Doral: and

**WHEREAS**, Due to Arts, Inc. is a nonprofit that educates youth in the performing arts while instilling values of community service. Through arts education and community programs such as food drives and volunteer initiatives, Due to Arts promotes youth

empowerment and cultural enrichment in alignment with the City of Doral's mission of fostering leadership and community development.; and

**WHEREAS**, in accordance with Section 2-79 of Municipal Sponsorships, Councilwoman Maureen Porras proposes a donation of Two Thousand Dollars and 00/100 (\$2,000.00) to support the efforts of Due to Arts, Inc; and

**WHEREAS**, the sponsorship will aid this organization in continuing their vital work within the community; and

**WHEREAS**, the City Council finds that the proposed municipal sponsorship complies with Section 2-79 of the City's Code of Ordinances and finds that the donation serves a municipal purpose.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA:**

**Section 1. Authorization.** The City of Doral hereby authorizes a municipal sponsorship in the amount of Two Thousand Dollars and 00/100 (\$2,000.00) to Due to Arts, Inc., pursuant to Section 2-79 of the City's Code of Ordinances.

**Section 2. Implementation.** The City Manager is hereby directed to take all steps necessary to implement the terms of this Resolution including the disbursement of funds consistent with the City's fiscal policies.

**Section 3. Effective Date.** This Resolution shall take effect immediately upon its adoption.

The Prime Sponsor of the foregoing resolution is Councilwoman Maureen Porras.

The foregoing Resolution was offered by Councilmember Reinoso who moved its adoption. The motion was seconded by Councilmember Pineyro and upon being put to a vote, the vote was as follows:
