WHEREAS, in the spirit of helping local community performing arts organization, the City Mayor and Council hereby approve the use of the City logo by the Miss Teen pageant for their 2026 program.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1. Recitals.</u> The foregoing recitals are true and correct and are incorporated herein by this reference as if fully set forth in this section.

Section 2. Approval of the City Logo. In accordance with Section 2-1.2 (f), "Taller en Accion Arts Academy", is hereby authorized to use the City logo for the
