A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE SHARED PARKING USE AGREEMENT WITH THE OFFICE OF THE SUPERVISOR OF ELECTIONS FOR MIAMI-DADE COUNTY, FOR THE PURPOSE OF PARKING AT DORAL CENTRAL PARK DURING ELECTIONS AND ELECTION RELATED ACTIVITIES; AUTHORIZING THE CITY MANAGER TO EXECUTE THE SHARED PARKING USE AGREEMENT; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Office of the Supervisor of Elections for Miami-Dade County ("SOE") maintains its main office adjacent to the southeast corner of Doral Central Park in the City of Doral, Florida; and

WHEREAS, the City of Doral ("City") owns and maintains Doral Central Park, including a parking strip located on the southeast corner of Doral Central Park ("Parking Area"); and

WHEREAS, in 2004, Miami-Dade County, through Resolution No. R-1468-04, and the City of Doral, through Resolution No. R-04-100, entered into an Interlocal Agreement for the conveyance of three County parks, including Central Park ("ILA"); and

WHEREAS, in accordance with the ILA, the City of Doral agreed to allow what is now Doral Central Park to be used "for purposes of parking during elections and election related activities;" and

WHERAS, in accordance with that agreement, the SOE intends to use Doral Central Park for additional parking during elections and election related activities to accommodate staff, poll workers, and members of the public; and

WHEREAS, the City, consistent with its continuing obligations under the ILA, will support the electoral process by allowing the SOE to utilize the Parking Area for overflow parking during elections; and

WHEREAS, the parties desire to enter into the Shared Parking Use Agreement ("Agreement") to establish the terms and conditions for the continued shared use and maintenance of the Parking Area; and

WHEREAS, City staff respectfully recommend that the Mayor and City Councilmembers approve the shared parking use agreement and authorize the City Manager to execute the agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval & Authorization. The Mayor and City Councilmembers hereby approve the Shared Parking Use Agreement with the Office of the Supervisor of Elections for Miami-Dade County for the provisions of utilizing Doral Central Park for parking during elections or elections related activities. The Mayor and City Councilmembers further authorize the City Manager to execute the Shared Parking Use Agreement, and to execute any other addendum, amendment, or document necessary to effectuate this agreement.

<u>Section 3.</u> <u>Implementation.</u> The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent with the Council's intent.
