## **RESOLUTION No. 25-31**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT AND THE USE OF THE CITY LOGO AND MARKETING SUPPORT REQUESTED BY DEREK HODES TO HOST THE "DOWNTOWN DORAL ARTS FESTIVAL" AT 5252 PASEO BOULEVARD DORAL, FL 33166, ALONG NW 53 STREET BETWEEN NW 87 AVENUE AND NW 84 AVENUE, FROM NOVEMBER 15, 2025, THROUGH NOVEMBER 16, 2025, FROM 10 A.M. TO 6 P.M; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS Derek Hodes (the "Applicant") seeks approval from the City of Doral to host the "Downtown Doral Arts Festival" special event at 5252 Paseo Boulevard Doral, Fl. 33166, along NW 53<sup>rd</sup> Street between NW 87 Avenue and NW 84 Avenue; and

WHEREAS the purpose of this event is to showcase the City of Doral at the regional, state, and national levels by exposing the local businesses, merchants and renowned artists of different areas and elicit the residents and visitors to participate and enjoy this event; and

**WHEREAS** staff recommends that the Mayor and City Council approve the proposed "Downtown Doral Arts Festival" special event permit with conditions to be held from Saturday, November 15, 2025, through Sunday, November 16, 2025, from 10:00 a.m. to 6:00 p.m.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

<u>Section 2.</u> Approval. The special event permit for the "Downtown Doral Arts Festival" is hereby approved subject to the following conditions:

- 1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
- 2. The Applicant shall be required to have secure all required inspections and approvals prior to the event date.
- Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number to meet the requirements established by the Building Department.
- 4. Miami-Dade Fire Rescue may require the Applicant to provide and pay for fire watch personnel.
- 5. The Applicant shall comply with the comments made by the City of Doral Police Department and pay all applicable fees no later than thirty (30) days prior to the special event.
- 6. The Applicant shall provide to the City of Doral an acceptable certificate of insurance naming the city as an additional insured thirty (30) days prior to the event date.
- 7. Applicant shall secure a maintenance of traffic (MOT) permit from the City of Doral Public Works Department and any other applicable permits as required by the City and/or Miami-Dade County Department of Transportation and Public Works prior to event start date.
- 8. If approved by City Council, the Applicant shall coordinate with the City of Doral Public Affairs Department for city logo, inclusion of event information on City website, and promotion of event via City's newsletter, eblast, and social media.
- 9. All fees due must be paid within thirty (30) days upon special event approval. Total fees due for Downtown Doral Arts Festival special event are \$10,610.96 which represents \$10,245.96 for Police services and \$365.00 for Planning and Zoning and Technology fees.

<u>Section 3.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
