A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER WITH GANNETT FLEMING, INC. FOR THE PROVISION OF CONSTRUCTION ENGINEERING AND INSPECTION (CEI) SERVICES FOR THE TROLLEY INFRASTRUCTURE IMPROVEMENTS AT IDENTIFIED LOCATIONS IN AN AMOUNT NOT TO EXCEED ONE HUNDRED TWELVE THOUSAND, NINE HUNDRED THIRTY FIVE DOLLARS AND 36/100 (\$112,935.36); AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral Public Works Department (PWD) wishes to secure a firm for the provision of Construction Engineering and Inspection (CEI) services for the construction of ten (10) new bus stop shelters and sidewalk improvements at locations identified considering ridership demand and infrastructure needs; and

WHEREAS, Gannett Fleming, Inc. is a prequalified provider of professional engineering and architectural services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council on March 13, 2024, via Resolution No. 24-54; and

WHEREAS, Gannett Fleming, Inc. provided a proposal dated July 30, 2024, on a time and material basis in a not to exceed amount of \$112,935.36; and

WHEREAS, staff respectfully requests authorization for the City Manager to execute Work Order No. 5 with Gannett Fleming, Inc. for the provision of Construction Engineering and Inspection (CEI) services for bus stop shelters at identified locations, in an amount not to exceed \$112.935.36; and

WHEREAS, funding for this request is available from the Public Works Transportation Fund, Account Num. 101.80005.500650.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Approval. The Work Order between the City of Doral and Gannett Fleming, Inc. for the provision Engineering and Inspection (CEI) services for ten (10) bus stop shelters at identified locations, in an amount not to exceed \$112,935.36, a copy which is attached hereto as Exhibit "A", is hereby approved.

Section 3. Authorization. The City Manager is authorized to negotiate and execute the work order with Gannett Fleming, Inc., and expend budgeted funds on behalf of the City in furtherance hereof.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

The City of Doral authorizes the firm of Gannett Fleming, Inc. to proceed with Construction Engineering and Inspection (CEI) Services for the construction of the Doral Trolley infrastructure Improvements, more specifically describe as the citywide installation of (10) bus shelter at current Trolley stops locations as of the date of this work order. The schedule requires the scope of work to be completed within 120 Calendar Days of NTP. You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal and revoke the award.

This Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated June 3, 2024 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. Work Order is not binding until the City of Doral agrees and approves this Work Order.
