A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO APPROVE THE REPLACEMENT OF THE CURRENT LICENSE PLATE READER SYSTEM AT TWO INTERSECTIONS WITH MILLENIUM PRODUCTS INC. IN AN AMOUNT NOT TO EXCEED SEVENTY FOUR THOUSAND. EIGHT HUNDRED TEN DOLLARS AND (\$74,810.72) UTILIZING GSA CONTRACT No. GS-07F-0031W; PROVIDING FOR **AUTHORIZATION**; PROVIDING **FOR** RECITALS; AND PROVIDING FOR AN INCORPORATION OF **EFFECTIVE DATE**

WHEREAS, The City of Doral has been implementing license plate readers since 2015. The LPR system has served as an investigating tool for the Doral Police Department, apprehending wanted people and recovering stolen vehicles. It has also assisted other; and.

WHEREAS, As part of our ongoing commitment to improving our operations and ensuring we use the most up-to-date technology, we are initiating a refreshment of our old License Plate Reader; and

WHEREAS, This upgrade is essential for maintaining high standards of accuracy, efficiency, and security in our operations. It will significantly enhance our operational capabilities and overall efficiency and security; and

WHEREAS, notably, Section 119.0725 (b), Florida Statutes, creates a public records exemption related to cybersecurity. Specifically, the statute makes any information related to critical infrastructure such as this confidential and exempt from public record requirements. In addition to the public records exemption, any portion of a meeting that might reveal such information is exempt from public meeting requirements.

See Section 119.0725(3), Florida Statutes+; and

WHEREAS, Section 2-322 of the City Code of Ordinances provides that the City may enter into contracts procured by other public entities and cooperative purchasing ventures. Accordingly, the City may solicit the services provided by vendors participating in General Services Administration (GSA) Multiple Award Schedule 334220 Security and Protection Products and Service Contract # GS-07F-0031W awarded to Millenium Products Inc; and

WHEREAS, funds for the aforementioned refresh are allocated in the IT Capital Account #: 001.22005.500640.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. The City Manager's Office respectfully requests that the Mayor and City Council Members authorize using GSA Security and Protection Products and Service Contract # GS-07F-0031W, to replace the current License Plate Reader system at two intersections. Service will be provided by Millenium Products Inc. in an amount not to exceed seventy four thousand, eight hundred ten dollars and 72/100(\$74,810.72). Funds are allocated in the IT Capital account 001.22005.500640.

Section 3. Implementation. The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
