

**RESOLUTION No. 25-72**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO PIGGYBACK AND UTILIZE THE CITY OF HOMESTEAD SOLICITATION No. 202120 FOR THE PROCUREMENT OF POOL MANAGEMENT AND LIFEGUARD SERVICES FROM MIAMI LIFEGUARDS LLC. (NOW KNOWN AS ONE STOP AQUATIC SAFETY, LLC.); PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Parks & Recreation Department respectfully seeks approval and authorization from the Mayor and City Councilmembers to authorize the City Manager to utilize the City of Homestead Solicitation No. 202120, for the procurement of pool management and lifeguard services; and

**WHEREAS**, The City of Doral will be opening Doral Central Park Aquatic Center in the near future, which will require professional pool management and lifeguard services to ensure the safety of patrons and compliance with industry standards. The City will be overseeing the operations and staffing of the Aquatic center and is actively working to hire and on-board both full time aquatic managers and part time lifeguards; and

**WHEREAS**, One Stop Aquatic Safety, LLC. currently provides lifeguards and aquatic management services for multiple municipalities and national resorts. All lifeguards are employees of vendor and hold the required certifications and years of experience. Any lifeguards provided to the City will be supervised by City staff and participate in on-going trainings to ensure the highest standard of safety and customer service; and

**WHEREAS**, Approving and entering into an agreement with One Stop Aquatic

Safety, LLC. allows the City the ability to bring on additional lifeguard services on an as-needed basis, particularly during high peak seasons; and

**WHEREAS**, the City has confirmed that it can utilize the results of the City of Homestead Solicitation No. 202120 under the cooperative purchasing guidelines, allowing for cost savings and the avoidance of duplicative procurement efforts; and

**WHEREAS**, One Stop Aquatic Safety, LLC has been awarded the contract under Solicitation No. 202120 for the City of Homestead and has demonstrated expertise in providing pool management and lifeguard services to municipalities across Florida; and

**WHEREAS**, under this agreement, the City of Doral will issue its own purchase orders, process invoices, and handle payments directly with One Stop Aquatic Safety, LLC, while adhering to the terms and conditions set forth in the original contract awarded by the City of Homestead; and

**WHEREAS**, the total amount for the procurement of pool management and lifeguard services will not exceed budgeted funds allocated under the Parks & Recreation Account 001.90005.500310 (Professional Services)

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval & Authorization.** The Mayor and City Councilmembers hereby approve the procurement of pool management and lifeguard services by utilizing the results of the City of Homestead Solicitation No. 202120.

**Section 3. Implementation.** The City Manager and the City Attorney are hereby

authorized to take such action as may be necessary to implement the provisions of this Resolution.

**Section 4. Effective Date.** This Resolution shall take effect immediately upon adoption.
